## ADRODDIAD SCAA SBAR REPORT

### Sefyllfa / Situation

The Board of Hywel Dda University Local Health Board (HDdUHB), in its role as corporate trustee of the charitable funds held by HDdUHB, is requested to ratify the approval of one charitable funds application presented to the Charitable Funds Committee at its meeting on 26<sup>th</sup> September 2022.

#### Cefndir / Background

HDdUHB has been appointed as Corporate Trustee of the charitable funds by virtue of Statutory Instrument 2009 No. 778 (W.66) and that its Board serves as its agent in the administration of the charitable funds held by the University Health Board.

The Charitable Funds Committee (CFC) has been established as a Committee of HDdUHB and constituted from 22<sup>nd</sup> July 2010.

The purpose of the CFC is to:

- Make and monitor arrangements for the control and management of the Board's Charitable Funds, within the budget, priorities and spending criteria determined by the Board and consistent with the legislative framework.
- Provide assurance to the Board in its role as corporate trustees of the charitable funds held and administered by the University Health Board.
- Agree issues to be escalated to the Board with recommendations for action.

The CFC is responsible for approving all charitable expenditure between £50,000 and £100,000 in accordance with the Committee's terms of reference and agreed scheme of financial delegation. Expenditure over £100,000 requires the approval of the CFC as well as the approval of the Corporate Trustee.

The report, attached at Appendix 1, was presented to CFC at its meeting on 26<sup>th</sup> September 2022 and, following discussion, the request for charitable funding received approval subject to ratification by the Corporate Trustee. The Corporate Trustee is requested to ratify the request for charitable funds expenditure of £200176.72 for the purchase of two echocardiography machines from the T460 Pembrokeshire Cardiology Equipment Fund.

Following the CFC meeting, the total amount required was confirmed as £192,976.72 due to a revision of the maintenance costs and all the items qualifying for charitable fund zero-rating VAT relief.

## ADRODDIAD SCAA SBAR REPORT

### Sefyllfa / Situation

This report is being presented to the Charitable Funds Committee to consider and approve an application for £200176.72 of charitable funding to support the purchase of two echocardiography machines, prior to presentation to the Board at its Public meeting on 29<sup>th</sup> September 2022 for ratification in its role as Corporate Trustee.

The need for two new echo machines (1 Vivid S70 (portable machine) and 1 Vivid E95) has been identified for several reasons. New trainee sonographers have been recruited in the Withybush General Hospital (WGH) Cardio-Respiratory Department and in order for the Sonographers to help reduce the waiting lists, extra machines are required to enable more scans to be undertaken at the same time. There is currently only one portable echo machine, meaning only one Sonographer is able to scan inpatients on the ward at a time. With an extra portable machine, WGH's inpatient echocardiograms will be done sooner, which would help significantly with hospital discharges.

Furthermore, with the Department's backlog of outpatients waiting for echocardiograms, secondary to COVID-19, more machines and Sonographers would enable waiting lists to be reduced as more outpatient lists will be carried out at the same time. There are several specialised, advanced clinics being carried out in the Department and in order to carry out these services long term, extra machines are needed in order for the routine and urgent transthoracic echocardiogram outpatient and inpatients lists to be performed alongside the clinics. New, up to date echo machines will also enable employees to work faster and increase productivity within the workplace. The need for more machines has been discussed and confirmed with the Head of Department and the Head of Service.

#### Cefndir / Background

There will be clear and direct benefits to patient care with more machines within the Department. Echocardiography is central to the assessment and management of all cardiac diseases and with more machines, patients will be waiting less time for diagnosis. There are several specialist clinics being delivered by the Echocardiography team at WGH, which helps to decrease Cardiologists' workloads and decreases Cardiology clinic waiting lists. These clinics also save patients from needing to travel to other sites for tests and include:

- Congenital defect clinics
- Valve clinics
- Dobutamine stress echo clinics
- Transoesophageal echocardiograms (which will be starting in the near future).

Extra machines will be needed in order for more routine/urgent transthoracic echo scans to be undertaken, in addition to the new specialised clinics.

Additionally, two new machines will reduce waiting times for urgent echocardiograms, such as oncology scans, which are performed as a comprehensive evaluation secondary to the therapeutic regimen used. Urgent and routine echocardiograms in the outpatient and inpatient setting would be performed sooner with new/extra machines for the Cardio Respiratory Department, which would significantly benefit patient care.

#### Asesiad / Assessment

Physiologists and consultants require regular access to maintain their clinics and ensure patients are able to be diagnosed and referred correctly. Currently, there are only three echo machines (this includes one portable machine for inpatient echos) within the Department, which are being shared between four Physiologists. With more trainee Sonographers and more advanced, specialised clinics being developed within the Cardio Respiratory Department, there are currently not enough machines available.

Current waiting lists for a transthoracic echo is approximately 4-5 months. With two extra machines, more routine and urgent echo lists would be performed daily, which would significantly reduce echocardiography waiting lists. Patients within these lists hold a significant clinical risk related to cardiac defects and anomalies, which will only be detected by echocardiography scan. The majority of these will be identified and monitored by detailed echocardiography examination within the WGH echo clinics. It is therefore imperative to be able to provide local, faster and regular access to patients awaiting echocardiography. In order to maintain service provision, investment in new, reliable and modern equipment is essential. It is equally important to ensure that access for the inpatient population in WGH is also maintained by having 2 portable machines within the Department.

Advice on an appropriate Echocardiography option has been received. The identified machines, Vivid E95 4d Ultra Edition and Vivid S70 R4, meet the requirements of the National Framework Agreement for Ultrasound The device is supplied by the NHS supply chain and as such, a saving of £22,786.26 has been identified. The overall cost of both machines is £162,966.72 exclusive of VAT.

Revenue Costs - Servicing/Maintenance of Equipment.

The total for maintenance of both machines is £37210+VAT to support with ongoing upgrade/servicing costs for the first five years post purchase (one year warranty and four years maintenance cover), should this bid be accepted. This will allow support to be commissioned with the manufacturers (GE) in line with existing financial and engineering requirements.
