ADRODDIAD SCAA SBAR REPORT Sefyllfa / Situation

This report provides updates on progress in relation to the implementation of Welsh Health Circulars (WHCs), which come under the remit of Sustainable Resources Committee (SRC) and its Sub-Committee structure. The Committee is requested to receive assurance from the lead Executive/Director or Supporting Officer on the management of WHCs within their area of responsibility, particularly in respect of understanding when the WHC will be delivered, any barriers to delivery, impacts of non/late delivery and assurance that the risks associated with these are being managed effectively.

Cefndir / Background

WHCs provide a streamlined, transparent and traceable method of communication between NHS Wales and NHS organisations relating to different areas such as estates, finance, governance, health professional letters, information governance, quality and safety, legislation, planning, performance and delivery, policy, public health, research, science, and workforce. WHCs are published on the <u>Welsh Government website</u>.

The Board has requested that WHCs that have not been implemented by the stated timescales should be closely monitored by its Committee structure, in order to provide assurance on the compliance and delivery of the outstanding WHC, in addition to an understanding of the impacts resulting from late/non-delivery.

Asesiad / Assessment

Since the previous update to SRC, the reporting requirements on WHCs have been strengthened. WHCs are not always clear in terms of implementation timescales, a result of which previously these were reported as "Amber" (i.e on schedule).

The Assurance and Risk Team have been seeking updates from leads on these WHCs to determine the planned date for implementation by the Health Board where a specific date is not provided in the guidance itself. The following RAG status is now applied to WHCs:

- **Green** = completed
- Amber = a plan is in place and on schedule to be completed by the timescale provided by the Lead Officer
- **Red** = behind schedule to the timescale provided by the Lead officer, or a plan (with date for implementation) is not yet in place

Recent operational demands and pressures have impacted on services' ability to reply to requests for implementation dates, however the Assurance and Risk Team will continue to seek updates on progress on the implementation of these WHCs as part of the bi-monthly service update process.

An update from each Supporting Officer, in respect of the WHCs that fall under the remit of SRC, is attached at Appendix 1.

This WHC was taken back by the Welsh Government (WG) representative following a national Heads of Information meeting, as the clinical coding process is unable to identify COVID patients until the clinical coding actually takes place. The Health Board are currently coding in excess of 95% completeness month on month. The WHC is currently being reviewed by Welsh Government, the outcome of which will either that it will be amended or withdrawn.

EDCIMS has now passed the necessary testing phases, and is available to Health Boards to implement. A further request has been submitted by the Head of Digital Programmes to DHCW for the funding model and implementation plan for EDCIMS. Following the receipt of the funding requirements, an agile digital business case will be developed and presented to the Agile Digital Business Group for consideration, highlighting the needs of the service, ease of implementation, strategic fit, and overall affordability. Once considered by the Group, a recommendation will then be given to SRC for approval. As at July 2022, a bid to support the implementation of EDCIMS has been submitted to the Capital Planning Group, and currently awaiting confirmation of the necessary funding. Given the pressures on the capital programme, funding is not expected to be approved - the expectation therefore is that planning will commence in FY 2023/24, with implementation in the following financial year.
