- Can you please provide the figures for the number of patients in all hospitals in your trust for each year of the last 10 years, including 2021 YTD, that were diagnosed as suffering from Myocarditis.
- 2. Can you please provide specific numbers for each of the following age groups please? Under 18, 18 to 30, 30 to 40, 40 to 50, 50 to 60, 60 to 70, 70+
- 3. For the figures pertaining to the last 3 years can you please indicate how many had received a single injection of the experimental chemical concoction you call "Covid 19 vaccines"?
- 4. For the figures pertaining to the last 3 years can you please indicate how many had received two injections of the experimental chemical concoction you call "Covid 19 vaccines"?
- 5. For the figures pertaining to the last 3 years can you please indicate how many had received NO injections of the experimental chemical concoction you call "Covid 19 vaccines"?

Response:

Hywel Dda University Health Board (UHB) is unable to provide you with the information broken down by age group and calendar year, as requested for questions 1 and 2, as there is a potential risk of identifying individuals if these details were disclosed. The UHB is therefore withholding this detail under Section 40(2) of the Freedom of Information Act 2000 (FoIA).

Additionally, where the figures in the tables below have been replaced with an asterisk (*), this is due to the low numbers (5 and under). Therefore, there is again a risk of identifying individuals and so, the same exemption is being applied.

This information is protected by the Data Protection Act 2018/General Data Protection Regulations 2016 (GDPR), as its disclosure would constitute unfair and unlawful processing and would be contrary to the principles and articles 6 and 9 of the GDPR. This exemption is absolute and therefore there is no requirement to apply the public interest test.

In reaching this decision, the Data Protection Act 2018/General Data Protection Regulations 2016 defines personal data as data which relates to a living individual who can be identified solely from that data or from that data and other information which is in the possession of the data controller.

However, whilst operating in accordance with the Section 45 Freedom of Information Code of Practice, the UHB has a duty to provide advice and assistance and therefore, provides the information in a disclosable format.

1. The UHB provides, within the table below, the number of patients admitted with a diagnosis of Myocarditis, bi-annually from 2011 to 2020 and 1 January to 31 October 2021.

3. - 5. The COVID-19 vaccination was not approved for use in the UK until December 2020. Therefore, the UHB does not hold data prior to this.
