ADRODDIAD SCAA SBAR REPORT <u>Sefyllfa / Situation</u>

The purpose of this report is to update the Board on relevant matters undertaken as Chief Executive of Hywel Dda University Health Board since the Board meeting held on 25 May 2023.

Cefndir / Background

This report provides the opportunity to present items to the Board to demonstrate areas of work that are being progressed and achievements that are being made, which may not be subject to prior consideration by a Committee of the Board, or may not be directly reported to the Board through Board reports.

Asesiad / Assessment

Register of Sealings

The Health Board's Common Seal has been applied to legal documents and a record of the sealing of these documents has been entered into the Register kept for this purpose. The entries at **Appendix A** have been signed by the Chair and Chief Executive or the Deputy Chief Executive (in the absence of the Chief Executive) on behalf of the Board (Section 8 of the Health Board's Standing Orders refers).

Consultations

The Health Board receives consultation documents from a number of external organisations. It is important that the Health Board considers the impact of the proposals contained within these consultations against its own strategic plans, and ensures that an appropriate corporate response is provided to highlight any issues that could potentially impact upon the organisation. A status report for Consultation Documents received and responded to is detailed at **Appendix B**, should any Board Member wish to contribute.

Strategic and Operational Issues: Local and Regional

Escalation Status

The latest Targeted Invention (TI) meeting was held on 21 June 2023, where the Health Board provided Welsh Government (WG) with progress against the key deliverables of TI and Enhanced Monitoring. The outcome of this meeting will be reported to the Audit and Risk Assurance Committee on 15 August 2023. The Health Board continues to operate its own internal governance arrangements previously approved by the Board, with the Chair and Audit Chair being 'In Attendance' Members of the Escalation Steering Group, and the Chief Executive being required to attend each ARAC meeting.

Update on the end of year Joint Executive Team Meeting: 19 May 2023

Pre-COVID-19, members of the Executive Team and I met bi-annually with the Chief Executive NHS Wales and members of their senior team as a Joint Executive Team (JET). These meetings have resumed by Teams virtually, with the most recent end of year (2022/23) meeting held on 19 May 2023, chaired by the Deputy Chief Executive NHS Wales.

There was a wide ranging discussion during the meeting, with an acknowledgement that the year ahead is going to be challenging for the Health Board with a focus on the Ministerial priorities. WG was clear that the Health Board must comply with a number of statutory duties, from financial control to the duty to improve the quality of services for patients. There were a number of actions agreed to focus on going forward:

- Submit an improved financial plan by 31 May 2023;
- Make sustained progress towards a finance improvement trajectory;
- Deliver against the planned care recovery actions to ensure that there are no patients waiting over 52 weeks for a first outpatient appointment and over 104 weeks for the Referral to Treatment (RTT) pathway;
- Improve and sustain consistent delivery of urgent and emergency care services; and
- Reduce the cancer backlog and meet performance trajectories.

UK Covid-19 Inquiry: Module 4

Members are advised that a further module - Module 4 - opened on 5 June 2023, having a Core Participant (CP) application window of 5 June to 30 June 2023. The provisional scope of this module relates to the development of Covid-19 vaccines and the implementation of the vaccine rollout programme in England, Wales, Scotland and Northern Ireland. The Executive Team considered the option to apply for CP status in a meeting held on 20 June 2023. On the advice of the Public Inquiry Readiness Governance Group, and supported by the Executive Team, a decision was taken that the Health Board would not apply for CP status for Module 4.

Members are advised that the Inquiry can request a statement and evidence from the Health Board even if it is not a CP (Rule 9 request), which as Module 4 relates to vaccination and therapeutics, seems highly likely.

Regional Integration Fund: Memorandum of Understanding

The Regional Integration Fund (RIF) replaces previous Integrated Care Fund (ICF) and Transformation Fund (TF) schemes, and from 1 April 2022, all funding is allocated to the HB as Banker. The RIF differs from the ICF and TF schemes, in that the Regional Partnership Board (RPB) must match fund schemes: 10% for the Accelerating Change Fund and 30% for the National Delivery Model Embedding Fund. Embedding Fund projects can move into the Integrated Mainstreaming Fund after three years, with recurrent WG funding and an expectation of 50% matched funding from partners.

WG guidance states that the RPB (that oversees the RIF) must have a Memorandum of Understanding (MoU) in place that sets out the agreed governance, accountability and decision making processes, including appropriate arrangements to enable scrutiny of investment decisions by the sovereign bodies.

The RPB is hosted by Carmarthenshire County Council on behalf of the four partners – the Health Board, Carmarthenshire County Council, Pembrokeshire County Council and Ceredigion County Council. In July 2022, due to its role as Banker, the HB made a decision to seek legal advice to draft a MoU, and each partner would then need to seek independent legal advice on its content.

A first draft has been circulated to the RPB members through the Integrated Executive Group (IEG) with clear advice that this is drafted for the Health Board and the partners must take their own legal advice. Once there is an agreed version, Members will be invited to consider and approve the MoU to effect completion.

<u>Health Improvement and Wellbeing Centre, Llanelli</u> The development of the Health Improvement and Wellbeing Centre remains a strategic priority for the Health Board, Dyfed Area Planning Board and WG.

In recent months, the Health Board held an engagement event with the local community to discuss the intended service provision at the centre, and provide the opportunity to meet the local service providers.

A date is awaited for the consideration of the planning application by Carmarthenshire County Council following the submission of additional information addressing perception of harm concerns and a transport statement. The additional information submitted provides details of the benefits to the local population of the proposed health improvement services that will be delivered from the centre, and highlights that there is little evidence to support local concerns in relation to community safety, or an increase in either crime or anti-social behaviour, and that the proposed centre does not conflict with any policies related to safe and secure communities.
