ADRODDIAD SCAA SBAR REPORT

Sefyllfa / Situation

This report seeks to summarise draft well-being plans for Public Service Boards (PSBs) across the Hywel Dda UHB area. Plans are accurate as of 3rd October 2022.

Cefndir / Background

The Wellbeing of Future Generations (2015) Act (Wales) established PSBs for each local authority area in Wales. The members of each of the 3 PSBs in the HDdUHB area include the Local Authority, HDdUHB, the Fire and Rescue Service and Natural Resources Wales. In addition to these members, each PSB should also invite Welsh Ministers, Dyfed Powys Police, Voluntary Organisations and other local partners who carry out public functions.

Each PSB is tasked with improving the economic, social, environmental and cultural well-being of its area by working to achieve the well-being goals. PSBs do this by assessing the state of economic, social, environmental and cultural well-being in its area, and setting objectives that are designed to maximise the PSBs contribution to the wellbeing goals.

Each PSB must prepare and publish a local well-being plan setting out its objectives and the steps it will take to meet them. It must say why the PSB feels their objectives will contribute within their local area to achieving the well-being goals, and how it has had regard to the Assessment of Local Well-being in setting its objectives and steps to take.

Well-being assessments were completed earlier this year and Well-being plans are now being developed. HDdUHB has a key part to play in the development of plans. A number of HDdUHB Executives have been key to discussions in drafting these plans and the Public

Health Directorate, through Principal Practitioners in Public Health, have analysed and contributed to draft plans.

Asesiad / Assessment

Summaries of the current draft wellbeing plans are as follows:

Carmarthenshire Local Wellbeing Plan

Carmarthenshire assessed the key themes identified from the Well-being assessment according to the level of priority and their certainty of happening. This then informed the discussion around areas to be focussed upon by PSB partners working collaboratively. The agreed priorities were:

- The high number of households continuing to live in poverty
- In-work poverty
- The increasing cost of living
- The comparatively high suicide rate among adults
- Climate change and the nature emergency
- Water pollution from nitrates and phosphates
- The projected significant increase of dementia.

A number of key themes were also identified which need further consideration and research including levels of childhood and adult obesity; the concerns of young people around bullying, cyber bullying and domestic violence; levels of drinking alcohol among adults; increasing referrals for domestic violence; levels of homelessness and those at risk of homelessness; higher rates of fly tipping; loss of public transport and high costs of residential and nursing care.

Based on the discussions that followed on these key themes, the following 5 objectives were agreed:

- Ensuring a sustainable economy and fair employment
- Improving well-being and reducing health inequalities
- Responding to the climate and nature emergencies
- Tackling poverty and its impacts
- Helping to create safe and diverse communities and places

The PSB then engaged with communities, key stakeholders and others such as Welsh Government, the Future Generations Commissioner and PSB partners to get views on the draft objectives and Plan. Actions to support the delivery of objectives above have been drafted in conjunction with PSB partners.

The draft plan will be published shortly and is subject to a 12-week consultation from October 2022 to Jan 2023.

Ceredigion Local Wellbeing Plan

The 4 main objectives for the Ceredigion Local Well-being Plan for 2023-28 have been agreed by the PSB. These are:

1. Work together to achieve a sustainable economy and builds on the strengths of Ceredigion
2. Work together to reduce inequalities in our communities and use social and green solutions to improve physical and mental health
3. Work together to deliver decarbonisation initiatives within Ceredigion to protect and enhance our natural resources
4. Work together to enable communities to feel safe and connected and will promote cultural diversity and opportunities to use the Welsh language.

Over the summer a task and finish group, including the PHT and HDdUHB, worked to agree some key actions under these four objectives with the draft plan submitted to Welsh Government at the beginning of September. The place-based approach that the PSB has adopted over the last year or so will continue in this iteration of the Wellbeing Plan. Some useful mapping across to partner organisations' objectives was done, including to the Health Board's Planning Objectives.

The next stage in the timetable is the commencement of a 12-week public consultation on the Wellbeing Plan following agreement of the content of the 'Plans on a Page' by the PSB at their meeting on 20th September 2022. The PSB will now work to draft a set of key actions under each objective including how and when they will be delivered.

Pembrokeshire Local Wellbeing Plan

Pembrokeshire PSB began development of their wellbeing objectives at a workshop in May 2022 and collaborated with Ceredigion and Carmarthenshire to try to co-ordinate regionally. The four objectives shown below were kept at a high level to allow ongoing development including mapping of existing work and more detailed plans for execution of future work

At a PSB meeting on 27th September 2022, comments received during the engagement process were considered, links to existing activity and strategic intent/funded programmes were scoped, and leads for each of the objectives were discussed. There are already working groups in place that can pick up the lead for most of the objectives and priority areas. **One of the exceptions to note is the exception of the subgroup highlighted in yellow below, which HDdUHB were identified as the potential lead.**

This could fit with the Health Board **PO 4R**: *By March 2023 establish a regional oversight group, in partnership with PSBs and the RPB, to develop and promote a broad range of actions that will promote the social and green solutions for health and well-being and contribute to addressing the climate change emergency through green health and sustainability projects.*

Lead officers and sub-groups will need to develop and agree delivery arrangements during the period in red below, in order to allow time for these to be incorporated into the draft Well-being Plan for approval at the PSB meeting in November.

There is overlap and potential synergy between all areas' Wellbeing Plan objectives and HDdUHB planning objectives **4U** (on place-based initiatives around a social model of health), with **4K** on inequalities, with **4N** on the food system and **4R** on social and green solutions for health and well-being.
