ADRODDIAD SCAA SBAR REPORT Sefyllfa / Situation

In 2022, Hywel Dda's new Arts & Health Team presented to the Stakeholder Reference Group (SRG) information about their new role to promote and encourage the use of art within healthcare at Hywel Dda University Health Board (HDdUHB) for the benefit of patients, staff and communities. It was agreed that the Arts & Health Team continue to report progress to the SRG and engage with the Group.

The Arts & Health Team has been making good progress, uncovering opportunities for the arts to improve people's health and wellbeing across the Health Board and is in the process of cocreating a vision and plan for Arts & Health for HDdUHB and have been engaging with health professionals right across the Health Board, the arts sector and listening, learning and trialling activities. We are also launching a public engagement campaign inviting people to help shape the vision for Arts & Health at Hywel Dda called.

<u>Cefndir / Background</u>

The Arts & Health Team is funded also via the Arts Council of Wales (ACW) as part of a Memorandum of Understanding between ACW and the NHS Confederation Wales to put the arts at the centre of service transformation.

The Arts & Health agenda is of national significance, and the Hywel Dda Arts & Health Co-ordinator sits on a team of co-ordinators in other health boards across Wales and on the Welsh Government Cross Party Group for Arts & Health.

Asesiad / Assessment

The new Arts & Health Vision and Plan for Hywel Dda will be developed out of the engagement process to guide the Arts & Health Team and help them to develop a vision, in which creativity is at the heart of all our services to improve the health and wellbeing of patients, communities and staff across Hywel Dda through arts engagement.

At Hywel Dda University Health Board we have a shared vision with our communities for us to live healthy, joyful lives.

Our strategy called 'A Healthier Mid and West Wales: Our future generations living well' shares our vision for improving health and well-being for our communities in Pembrokeshire, Carmarthenshire and Ceredigion.

As part of this work, we are keen to build on the knowledge and growing evidence base that tells us that the arts have a powerful role to play in supporting health and wellbeing.

To help Hywel Dda develop a vision for Arts in Health, the new Arts & Health team is engaging with people from across the 3 counties of Carmarthenshire, Pembrokeshire and Ceredigion to

What we have been doing?

- Established an Arts in Health Steering group

- Co-producing an Arts in Health Charter and work plan



What is arts & health?

- Arts & health is any art intervention, commission or offer which is intended to improve health and wellbeing through arts engagement.
- 'The arts' Visual art, music, dance, theatre, creative writing, storytelling
- Arts in Health is delivered by and with artists, musicians, poets, song writers, theatre makers, choir leaders, with patients, people, staff and communities etc
- Arts & health is different to Arts Therapy which is delivered by healthcare professionals for psychotherapeutic benefit.
- There is much evidence to suggest that the arts can improve health and wellbeing.

Visual arts & crafts to improve mental health – reducing distress and enabling expression The arts can create environments which raise our spirits, soothe and comfort us and help us to feel better.

Live music to soothe and comfort patients Improving mobility, balance and preventing falls through **dance**. Enhancing healthcare spaces to enable patients to recover more quickly

Singing to connect and uplift people, improving memory, lung health and outcomes for long Covid patients. Reducing loneliness and social isolation through creative writing & stories on prescription

Arts Boost:

A collaboration with SCAMHS – Hywel Dda Children and Adolescent Mental Health Service

Findings:

- Improvements in mood and wellbeing
- increased confidence,
- development of self-expression,
- and feelings of safety via the provision of a calming, relaxing environment.

Recommendations:

- Explore opportunities to expand the offer
- Ensure future collaborations are underpinned with comprehensive and adaptable plans
- Use knowledge gained during the pilot to improve future implementations
- Promote extensively within the health board to ensure Arts in health interventions have the widest vital clinical leadership needed



Dance on Prescription:

2Ts GP Cluster Project

November 2022 – Spring 2023

Pilot dance on prescription project

- Patients with chronic illness and /or mobility issues
- AIMS: Increase physical activity, reduce social isolation and improve mental wellbeing
- Develop links with community MDT, local GP surgeries and local Arts and health organisation
- Available to patients of local GP surgeries in Llandovery, Llandeilo, Carmarthen and Whitland



Creative Prescribing Development Project

Embed evidence based arts in health into social prescribing practice.

- Partnership between Hywel Dda University Health Board (HDdUHB), Public Health Wales (PHW), the Social Prescribing Community of Practice (COP) HIEW and 6 Arts partners.
- Learning and Development engaging / referrers / barriers / facilitators
