Key Report Points

We have connected two Health Boards with each other to work on a claiming guide explaining what is expected from each Enhanced Service. In conjunction with this PPV will have input to ensure we put criteria for a Payment claim and then the document will be ratified and shared nationally.

Quarterly meetings are set-up where we have PPV, Counter Fraud, Primary Care and Finance present around the table to discuss a 6 month period of cases. The idea behind this is joined-up working and allows us to agree next steps for practices whether it be a Primary Care letter/visit, PPV one-on-one training or whether Fraud need to send a letter to the practice.

We are working with the Primary Care lead for GMS to schedule training events where we will present a powerpoint to demonstrate what is expected in patient medical records. This in conjunction with the offer we present of one-on-one training will help practices understand requirements fully.

All PPV audit reports are sent to the Director of Primary Care for information purposes and for feedback.

We completed the Ophthalmic training to contractors in an evening session. It was received well and we delivered in collaboration with the UHB Primary Care Team and Optometry Wales. The opportunity to work together yields great results and contractors left feeling it was a useful session.

Practices in the red and amber rating are in discussion with ourselves, Primary Care, Counter Fraud and finance in our quarterly meetings to be scheduled. The idea behind this being that we can decide on appropriate actions from the appropriate division.

We are currently in communication with the UHB surrounding the live launch of a recently successful pilot where we utilise trend analysis data to write out to patients to ensure they are receiving the services that have been claimed in their names.

PPV will begin work on a training package for Pharmacy for both presentation events and one-on-one training following the success in Medical and Ophthalmic nationally.

We have removed Flu from our verification audit on the basis of the CHOOSE pharmacy system being robust and have now agreed to pilot into two new advanced services, Collaborative Working and Quality & Safety.
