Sefyllfa / Situation

To provide the Audit & Risk Assurance Committee with an update report on the adequacy of arrangements in place for declaring, registering and handling interests, gifts, hospitality, honoraria and sponsorship during 2019/20, for review and onward assurance to the Board.

This is in line with the following paragraphs of Hywel Dda University Health Board's (HDdUHB's) Standing Orders:

- 7.4.1 'The Audit Committee will review and report to the Board upon the adequacy of the arrangements for declaring, registering and handling interests at least annually.'
- 7.6.5 'The Board Secretary will arrange for a full report of all offers of Gifts and Hospitality recorded by the LHB to be submitted to the Audit Committee at least annually. The Audit Committee will then review and report to the Board upon the adequacy of the LHB's arrangements for dealing with offers of gifts and hospitality.'

Cefndir / Background

Effective arrangements to manage the potential risks arising from interests, gifts, hospitality, honoraria and sponsorship in order to minimise their impact on decision making, constitute an important part of an organisation's governance arrangements. These arrangements should be designed to safeguard the principles of selflessness and objectivity, and provide members of the public with confidence that decisions are being taken in their best interests and not for the benefit of elected or appointed officials or their close personal associates.

In common with other public sector bodies, HDdUHB has established arrangements to manage such risks. These include:

- a policy on standards of behaviour that incorporates the acceptance and declaration of interests, gifts, hospitality, honoraria and sponsorship;
- establishing registers to record Board Members and staff declarations;

- procedures to record interests, gifts, hospitality, sponsorship and honoraria in the relevant registers;
- procedures to remind Board Members and staff of the policy's requirements, and;
- procedures to regularly report on the adequacy of arrangements in place for declaring, registering and handling interests, gifts, hospitality, sponsorship and honoraria to the Health Board's Audit & Risk Assurance Committee.

Asesiad / Assessment

Review of the Adequacy of Arrangements in Place for Declaring, Registering and Handling Interests of Board Members and Staff

It is a requirement within HDdUHB's Standing Orders that all Board Members must declare any personal or business interests they may have which may affect, or be perceived to affect, the conduct of their role as a Board Member. This includes any interests that may influence or be perceived to influence their judgement in the course of conducting the Board's business. Board Members must be familiar with the Values and Standards of Behaviour Framework and their statutory duties under the Constitution Regulations. Board Members must notify the Board of any such interests at the time of their appointment, and any further interests as they arise throughout their tenure as Board Members.

In line with these Standing Orders, a Register of Members Interests to record declarations of interests by Board Members (or interests held by family members or persons or bodies with which they are connected) has been established. This records the interests of Board Members at the time of their appointment, and is updated, as appropriate, to record any new interests, or changes to their interests throughout the year. Independent Members also receive advice and guidance on the policy as part of their induction programme; this is also contained within their Independent Member Handbook.

The Register of Board Members interests is made available at each Public Board meeting to enable scrutiny by any members of the public in attendance, and to offer further opportunity to Board Members to record any interests that may arise during the course of the meeting. Where individual Board members identify an interest in relation to any aspect of Board business set out on the Board's meeting agenda, this is declared at the start of the meeting and provision is made on each Board and Committee agenda for this to take place in order that appropriate action can be taken in response. All declarations of interests made at a meeting are recorded within the formal minutes.

Where Board Members are in doubt about what may be considered an interest, either at the time of their appointment, during their tenure of office, or during Board and Committee meetings, they are encouraged to seek advice from the Board Secretary.

An annual review is also undertaken as part of related party transactions/year-end processes, where each Board Member is required to confirm the accuracy and completeness of the register relating to their own interests.

The Register of Members Interests is made available on the Resource section of the Health Board's electronic Board and Committee management system, in order that Board Members can make easy reference to it for the purposes of updating their declarations.

The final version of HDdUHB's Register of Members Interests for 2019/20 is attached at Appendix 1.

Paragraph 7.3.1 of HDdUHB's Standing Orders also requires that 'The Board must ensure that the Board Secretary, on behalf of the Chief Executive, establishes and maintains a system for the declaration, recording and handling of LHB officers' interests in accordance with the Values and Standards of Behaviour Framework.'

In line with this requirement, a Register of Staffs Interests to record declarations of interests by employees (or those of their spouse, civil partner, partner or other relationship) has been established.

Building on the previous refinements made to include the need for a relevant Executive/ County/Assistant Director or Departmental/Line Manager's approval to confirm that the declaration of interest form has been reviewed and appropriate safeguards identified to address any conflicts or potential conflicts of interest, each positive declaration of interest(s) made is actively followed up with employees' approving managers, to confirm that safeguards are in place in order to receive an assurance on the adequacy of these arrangements.

HDdUHB's Standards of Behaviour Policy was revised in 2019 to specify those groups of employees who would need to complete an annual Declaration of Interest form (those staff deemed to be in high risk groups i.e. those whose role necessarily brings them into contact with external companies, contractors or suppliers, those who are able to initiate orders or those who are budget holders), and all specified groups of employees have been requested to complete a Declaration of Interest form during 2019/20.

Table 1 below identifies these high risk staff groups. Any positive declarations have been included in the HDdUHB Staff Register of Interests, with any nil declarations received logged and filed separately.

In terms of the numbers of staff declaring interests during 2019/20, Appendix 2 serves to demonstrate a much improved position with 56 positive declarations received compared to an average of 17 in previous years (and 268 nil declarations). However, acknowledging that declarations remain low in comparison to Hywel Dda's total workforce, discussions took place during 2019 to explore the potential for a package of software to be utilised within Hywel Dda which had been developed by Betsi Cadwaladr University Health Board (BCUHB), to host a standard approach/model for HDdUHB and potentially other Health Boards in Wales. This would be linked into Hywel Dda's Electronic Staff Record (ESR), to reach a position whereby computer generated requests for interests to be declared would be issued to all staff on an annual basis. Responses would then be receipted back into a database with the ability to generate relevant in-house reports to demonstrate compliance levels across the organisation.

This work has now been largely superseded by a Declarations of Interest functionality within ESR itself which was released on 1st April 2020, and is designed to provide similar reporting. Work is currently taking place, in conjunction with HDdUHB's local ESR Project Support Officer, to consider how this can be implemented and promoted within Hywel Dda, given the potential it creates to substantially increase the numbers of declarations of interests made.

The HDdUHB Register of Staffs Interests will be kept updated during 2020/21 and reported to ARAC as part of its annual requirement.

Review of the Adequacy of Arrangements in Place for Declaring, Registering and Handling Gifts, Hospitality, Honoraria and Sponsorship

HDdUHB's Standards of Behaviour Policy, which includes guidance on the declaration and registering of gifts, hospitality and sponsorship, underwent a full review in 2019, and was assessed against similar policies operating within Health Boards and Trusts in Wales to ensure that the content covered all required areas. HDdUHB took the lead for this piece of work, reviewing other Health Board's and Trust's Standards of Behaviour/Business Conduct Policies, to arrive at a composite report drawn from all the various policies in place.

This was shared through the Deputy Board Secretaries network for consideration of a standardised approach (although not necessarily a standardised policy, given the differences between Health Boards and Trusts in Wales).

From this HDdUHB's Standards of Behaviour Policy was drafted in line with the Health Board's Written Control Documentation Policy, and consulted upon widely via Global Consultation (between 7th and 21st August 2019) and also amongst targeted groups including HDdUHB's Staff Partnership Forum on 10th June 2019, and Workforce & OD Sub-Committee on 4th July 2019. This was to raise awareness both on the existing areas covered by the policy and on the new areas introduced. Members were asked to provide comment and cascade to their constituent groups for any further comments to be considered and fed into the final document.

The HDdUHB Standards of Behaviour Policy was approved by the Business Planning & Performance Assurance Committee on 29th August 2019 and made available on both the intranet and internet to all relevant parties including the public. The policy can be accessed via the following link and its next review will be due in August 2022:

The Standards of Behaviour Policy includes links to the Declaration of Gifts, Hospitality, Honoraria and Sponsorship forms, and further work has been undertaken on these during 2019 to make them easier for staff to complete via the on-line reporting system in place, with tick boxes to confirm that declarations are correct and complete prior to their submission.

In terms of publicising the HDdUHB Standards of Behaviour Policy, a number of avenues have been explored and opportunities taken during 2019/20:

- HDdUHB's Standards of Behaviour Policy features within all staff's Contracts of Employment which are issued to new employees within 12 weeks of commencing in post, and to all existing employees on a change of role. When signing their contract of employment, all staff must sign to confirm that they accept their appointment on the terms and conditions set out within the contract and contained within HDdUHB's Standards of Behaviour Policy. This requirement, and awareness of the policy continues to be featured routinely at corporate induction.
- New employees also receive information at Corporate Induction through the Welcome Handbook stating the following:
 - **Conditions of Service -** The pay and conditions of service/ contract of employment/Terms and conditions are determined by Agenda for Change. The handbook is available on the intranet. When signing your contract of employment, you are also agreeing to the Health Board's Standards of Behaviour Policy therefore everyone needs to familiarise themselves with its content accessible via the following link: http://www.wales.nhs.uk/sitesplus/documents/862/248-

- On commencement in post, Independent Members receive a programme of induction and are provided with an Independent Member Handbook referencing HDdUHB's Standards of Behaviour Policy.
- Bi-annual reminders are circulated via Global E-mail, together with a link to the policy, routinely to coincide with the periods when there is increased potential for the receipt of gifts i.e. at Christmas and Easter, to remind employees and Independent Members of the requirements of the policy and the need to declare any interests and report offers of gifts, hospitality, sponsorship and honoraria.
- Annual reminders are made on the 'Message from Employer' section of payslips, reminding employees and Independent Members of the requirements of the policy and the process for making declarations.
- Sessions are scheduled to be delivered at Medical Leadership Forum from September 2020 onwards

In terms of the numbers of staff declaring gifts during 2019/20, the HDdUHB Register of Gifts is attached at Appendix 3. Whilst it is acknowledged that numbers of declarations remain low (9 declarations of gifts received for 2019/20 compared to an average of 8 in previous years), this is likely to be attributed to the £25 threshold of gifts requiring registration in line with practice elsewhere, rendering the need for staff to declare 'incidental' gifts such as diaries, toiletries, etc, to be limited. Even so, where declarations of gifts have been received that represent a monetary value under the £25 threshold, these have been included in the register for completeness. Where gifts have been rejected for acceptance by an individual due to their transgression of the monetary value, advice has been provided on how to manage these for the benefit of patients or the wider Directorate/organisation.

The HDdUHB Register of Gifts will be kept updated during 2020/21 and reported to ARAC

as part of its annual requirement.

The HDdUHB Register of Hospitality, Sponsorship & Honoraria for 2019/20 is attached at Appendix 4. Again, whilst acknowledging the small albeit increasing numbers involved, and the potential for under-reporting of these declarations as recognised previously by the Audit & Risk Assurance Committee (30 declarations received for 2019/20 compared to an average of 14 in previous years), arrangements have been made to strengthen the Health Board's processes particularly in regard to sponsorship. In conjunction with work that has been undertaken to convert study leave forms to webform as opposed to a Microsoft Word document, fields have been included to identify within the funding source boxes the breakdown of funds to indicate whether external sponsorship is involved; this will enable a cross—check to take place between study leave forms and Declaration of Sponsorship forms, and act as a prompt for further declarations to be received.

The HDdUHB Register of Hospitality, Sponsorship & Honoraria will be kept updated during 2020/21 and reported to ARAC as part of its annual requirement.

In summary, work either on-going or planned for 2020/21 includes the following:

- Continue to maintain and update the HDdUHB Registers of Board Members Interests, Registers of Staffs Interests, Registers of Gifts and Registers of Hospitality, Sponsorship and Honoraria on a regular basis.
- Continue to follow up in discussion with approving managers, the adequacy of the arrangements in place to address any conflicts or potential conflicts of interest that may have been identified within employees' declarations of interests.
- Roll out the annual approach required to receive in declarations of interests to those employees deemed to be within high risk groups.
- Explore with ESR Project Support, the Declaration of Interest functionality within ESR, to promote and implement this within Hywel Dda t encourage further declarations.
- Continue to publish a bi-annual reminder via Global e-mail reinforcing employees and Independent Members obligations in regard to compliance with HDdUHB's Standards of Behaviour Policy and the requirement to declare interests, gifts, hospitality, sponsorship and honoraria.
- Continue to promote HDdUHB's Standards of Behaviour Policy and how to record interests, gifts, hospitality, sponsorship and honoraria as part of an annual awareness raising approach through the advice section of staffs pay slips.
- Continue to raise awareness of HDdUHB's Standards of Behaviour Policy and its associated requirements at all opportunities.
