Sefyllfa / Situation

The Audit & Risk Assurance Committee (ARAC) requires assurance on a number of financial areas, including the details around the numbers and values of Single Tenders awarded.

Cefndir / Background

The Standing Orders require that ARAC provides assurance to the Board that the University Health Board's assurance processes are operating effectively. Critical to this is Financial Assurance, which cannot be measured only by the UHB's main finance report, and requires further information in order to assess the control environment in place; the risk assessment and management process; and the control activities.

Single Tender information is provided to ARAC through the Financial Assurance report; along with this, on an annual basis, the Committee will be presented with a list of all Single Tenders awarded within the financial year.
