Sefyllfa / Situation

This update report is presented to the Finance Committee to:

- Note the Capital Resource Limit (CRL) for 2020/21;
- Note the value of capital expenditure currently anticipated to deal with COVID-19 for 2020/21 and the potential impact on the Health Board's CRL should no further Welsh Government (WG) funding be provided.

This report provides an update on the CRL for 2020/21.

The current CRL for 2020/21 has been issued with the following allocations:

There is also an allocation pending of:

• Advance Fire Compliance works at Withybush General Hospital (WGH): £0.350m

There is a risk that due to the impact of COVID-19 on the availability of WG capital funding that there will be no further additional allocations available to progress new capital projects during 2020/21.

A provisional allocation for the Discretionary Capital Programme has been presented to the Capital Estates IM&T Sub-Committee This is subject to Executive Team approval.

The value of capital orders placed by the Health Board to date on COVID-19-associated items which is expected to impact on the 2020/21 position is £9.960m. Further potential costs of £5.857m have been identified as costs that may need to be incurred to deal with the impact of the lockdown and the re-opening of services.

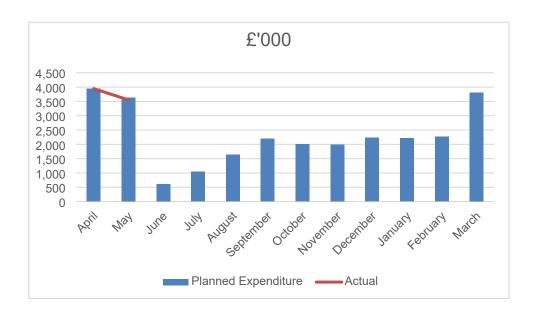

The potential/ anticipated costs reflect costs that will be incurred on:

- Time delay due to COVID-19 planning and social distancing legislation on Women & Children Scheme in Glangwili General Hospital (GGH).
- Costs of Vacuum Insulated Evaporator (VIE) plant in GGH should this progress.
- Works to Intensive Care Unit (ICU) on all sites, if all works are undertaken.
- Works to side rooms and Accident and Emergency in GGH, if the work is undertaken.
- Cardiology equipment to enable community working, if the equipment is procured.

The detailed information on the additional costs on the Women & Children Scheme in GGH is being shared with NHS Wales Shared Services Partnership: Specialist Estates Services on a weekly basis. The other schemes are being considered at the Bronze Groups for suitability and will require Gold Strategic Group approval and a funding source identified prior to being progressed.

An expenditure profile for the 2020/21 Capital Programme is shown below:



Further work is being undertaken by Hywel Dda University Health Board's (HDdUHB) cost advisors on the All Wales Capital Programme profiles for 2020/21 to reflect the impact of lockdown and the ongoing impact of COVID-19 and social distancing legislation on the programme. The Discretionary Capital Profile will be further reviewed with Estates, IT and the Deputy Director of Operations once detailed expenditure plans have been confirmed.

Total capital expenditure as at Month 2 was £7.498m, of which £6.367m related to COVID-19. Digital funding of £0.743m has currently been confirmed by Welsh Government for COVID-19; no further funding has been assumed in Month 2 for the cost of COVID-19. If all of the expected capital costs materialise in 2020/21 and no further WG funding is forthcoming, then the Health Board will breach its CRL by £15.075m in year.
