Sefyllfa / Situation

This report is intended to update the Committee with information on Financial Governance and Value for Money considerations in relation to COVID-19 following the report that was presented to the 28th April 2020 meeting.

The report will also update the Committee on

- the work undertaken to regularise the expenditure incurred within the organisation's scheme of delegation
- the work undertaken to review orders that have not yet been delivered within the scope of the current agreed escalation plan.

Cefndir / Background

Hywel Dda University Health Board (HDdUHB), in common with all health and social care providers in Wales, has faced unprecedented challenges during this time of response to COVID-19. HDdUHB has made decisions at pace to protect both staff and patients and, for reasons of expediency, has not always be in a position to follow the scheme of delegation as written. Where this has occurred, we have documented the reason for this and ensured that decisions have been regularised through the appropriate governance processes.

Asesiad / Assessment

Since the previous Finance Committee, the following work has been undertaken to review and update the appendices shared at the last meeting:

Appendix 1

Workforce & OD have provided details on the actual numbers of staff recruited through the COVID-19 recruitment process.

Gold Strategic Group was asked on 18th May 2020 to approve the expenditure in relation to the actual number of staff recruited. The information verified to date is for the following staff groups:

- HCSW
- HCSW Student Nurses
- HCSW Medical Students
- Porters
- Laundry
- Catering
- Domestics
- Semi-Skilled
- Informatics additional staff costs

Further work is still required to identify the actual cost of medical staffing changes and nurse staffing changes.

A paper was submitted to Gold Strategic Group on 4th May 2020 together with a follow up on 18th May 2020 to approve the expenditure decisions detailed in Appendix 1, 2 and 3 to regularise the expenditure within the organisation's scheme of delegation.

In line with the Health Board's scheme of delegation and standing financial instructions, a paper has been prepared for the Audit and Risk Assurance Committee (ARAC) to review the items of expenditure detailed in Appendix 2 and 3.

Appendix 4

This appendix provides a schedule of COVID -19 related orders raised which are over £25,000 where deliveries have not currently been received. Further work has been undertaken to review the content of this schedule with members of the Bronze Acute Group and Procurement to consider whether there are any opportunities to cancel/cease some of these orders. Following discussion with the Clinical leads in these areas, and consideration by Bronze Acute Group on 13th May 2020, the items highlighted in yellow are considered as orders where the Health Board should contemplate reducing the volumes ordered or cancelling the orders completely. This schedule was also considered by the Silver Tactical Group on 15th May 2020. Both Bronze Acute and Silver Groups have agreed that these items are not required within the scope of the current agreed escalation plan. Gold Strategic Group ratified this decision on 18th May 2020. The Procurement team will now liaise with the suppliers to action this decision. The total value of orders to be reduced or cancelled is £1,467,000.

A summary report will be also be prepared to update the Board at its next meeting.

The costs reported in Appendices 1-4 are all gross costs to the Health Board and we are working closely with Welsh Government to understand the funding arrangements associated with these costs.
