Sefyllfa / Situation

The Dyfed Powys Counter Terrorism Local Safety Profile (CTLP) is due to be published in May 2024 so was unavailable prior to the Health and Safety Committee meeting on 7 May 2024. Therefore, the focus of this update relates to the latest information on Martyn's Law, also known as the Terrorism Protection of Premises Bill. This is expected to become law in 2024.

The Bill is a legislative response to the findings of the Manchester Arena Inquiry and is designed to reduce the risk to the public from terrorism by the protection of public venues. The law will require owners and operators of venues and public spaces to put in place measures to keep the public safe from a terrorist attack, with the level of measures required based upon the capacity, size of venue and nature of activity taking place.

Cefndir / Background

We have previously reported and considered how the proposed duty might impact the health and social care sector. Further clarity has been now published that indicates that NHS hospitals and premises used for the provision of health care will be a **qualifying activity**.

In brief, **qualifying public premises** will be subject to the requirements in the Bill. For example, those having a minimum public capacity of 100 people; public access this includes activities such as entertainment, leisure, health care and education.

Qualifying public premises are then separated into two tiers. Section 3 sets out that standard duty premises have a capacity of between 100 and 799 people, and **enhanced duty premises** have a capacity of 800 or more.

Requirements for **enhanced duty premises** and qualifying public events include:

- An enhanced terrorism risk assessment that is reviewed with each material change to or use of the premises and at least annually.
- Terrorism protection training for relevant workers.
- Reasonably practicable security measures to be put in place.
- · The appointment of a designated senior officer.
- The preparation and maintenance of a security plan.

The regulator and sanctions

The Bill creates a familiar framework of regulatory inspections and sanctions for contravening a relevant requirement. The proposed approach emulates concepts already established in other elements of premises for example health and safety, fire safety.

In terms of the regime:

- Qualifying premises will need to be registered with the regulator. It is assumed the resulting register can then be used to inform inspection activity.
- Proactive inspections are envisaged the impact assessment anticipates the regulator inspecting an estimated 5% of premises each year with much of the associated costing extrapolated from Health and Safety Executive (HSE) data regarding staffing ratios and costs.
- The Bill places key duties on the 'person responsible', which can be either an organisation or an individual. The extent of their obligations will depend on whether the premises are standard or enhanced duty.
- The Bill also creates a 'designated senior officer' role, which must be an individual and – where the 'person responsible' is a business – this must be fulfilled by a director or senior officer of that organisation. The regulator must be told who this person is.
- Enhanced duty premises and qualifying events must prepare and submit a security plan to the regulator, with the detail still to be prescribed by regulations.

The identity of the regulator remains unknown. Key to its effectiveness will be adequate resourcing, something recognised in the impact assessment published with the Bill. It is possible that a new regulatory body will be set up but equally that the responsibility will be added to an existing authority's remit. Whatever the conclusion, the Government has been clear that it expects most organisations will want to comply with the legislation and that the primary function of the regulator will therefore be in providing guidance. However, the regulator will also have a variety of enforcement tools to call upon in the event of a contravention.

Asesiad / Assessment

Key Messages

Hywel Dda University Health Board (HDdUHB) already has existing major incident response procedures in place that would assist in demonstrating that certain control measures and contingencies are in place for certain incidents.

The Counter Terrorism Safety Adviser from Counter Terrorism Policing undertook a site survey at each of the four general hospital sites in 2023 and an 'official sensitive' restricted report was received in January 2024. The report highlighted a number of areas that would need to be improved if aspects of the impending Terrorism Protection of Premises Bill is to be fully complied with. These will be discussed as part of the Security Update at In-Committee.
