Sefyllfa / Situation

This report is presented to the Health and Safety Committee (HSC) to provide an update on arrangements for the management of Violence and Aggression (V&A). This report also includes incident data and violence and aggression risk management arrangements.

Cefndir / Background

The table below shows a comparison with data recorded for previous quarters and shows a consistently high number of incidents being reported by staff.

88 out of 294 Incidents still hold no patient details despite requests by the Violence and Aggression Case Manager. This lack of information hampers the ability to progress actions and remains a clear Datix training requirement. The Violence and Aggression Case Manager scrutinises Datix coding's, a high percentage are changed to ensure the most accurate classification is recorded by the Health Board under its assurance and quality compliance.

To aid improvement National Violence and Aggression Case Managers and the Anti-Violence Collaborative are now looking to introduce and promote the use of better codes and data capture through amendments to the Datix system.

Upon reviewing and obtaining information regards reported incidents it was established that 187 incidents could be attributed to patient conditions and therefore classified as clinically challenging behaviour, 31 incidents do not contain sufficient data and the remaining incidents do not appear attributable to patient conditions.

The contributory factors required to establish correct classification codes are currently not accurately captured at the time of reporting due to the current Datix system configuration. Improvements will be made to the system once agreed by the NHS Wales V&A Case Managers Group and the Welsh Risk Pool and Datix (Once for Wales) Project Team.

The list below are descriptions of the incidents recorded as 'severe' by the reporter. Whilst acknowledging the impact any violent and aggressive incident can have on individuals this does indicate a need for staff to correctly categorise incidents when they occur.

 Homophobic incident towards staff by patient with cognitive deficit, no physical harm caused.

- 2. Assault with call bell to staff and minor hand injuries.
- 3. Assault and aggression by learning disability patient minor injuries x 4
- 4. Assault by cognitive deficit patient- punch to leg, minor injuries
- 5. Theft and aggression by patient in A&E arrested by Police, no injuries
- 6. Aggression by patient with cognitive deficit trying to abscond, no injuries
- 7. Aggression by patient in A&E Dept, removed by Porters, no injuries
- 8. Patient with learning disability threatening staff and public in GP surgery, no injuries caused
- 9. CDAT service user said he'd like to stab staff for reporting domestic violence no injuries caused.
- 10. Patient with cognitive deficit, aggressive and waving a razor at staff, no injuries.

Porters were recorded on the Datix system as being called to 54 incidents to assist; however, this number is significantly higher and is under recorded and reported on the Datix system.

The Security Adviser and V&A Case Manager work collaboratively and during the last quarter have made numerous visits to wards throughout the Health Board area to offer support advice and challenges to inappropriate behaviours and V&A towards staff as well as assisting in the completion of risk assessments.

Police Activity

Police were recorded as being called on 33 occasions, but the actual resource demand based upon Police data is higher than the information captured via Datix. Typically, this can relate to staff seeking Police assistance, searching for absconding patients, undertaking welfare checks as well as conveyance of higher risk or violent patients.

Police practice of dropping off persons at locations without adequate risk information or appropriate handover has been identified as an area of bad practice and concern, resulting in several incidents particularly within Health Board Emergency Departments. These concerns have been raised with Dyfed Powys Police Senior Management and information cascaded to Operational Officers.

The following are examples of the Police actions during the last quarter.

- 1. Patient arrested for assault at Emergency Department. Convicted of offences and restraining order obtained.
- 2. Police attended at Community Mental Health premises and arrested aggressive service
- 3. Police attended at Emergency Department and arrested a patient who had kicked staff in the stomach.
- 4. Police attended at Emergency Department and arrested patient who was aggressive and found to have stolen Health Board property.
- 5. Police attended at Emergency department, arrested and removed aggressive patients x 5

6. Police attended at a Mental Health unit where an intoxicated member of the public was aggressive and attempting to force entry.

Risk Management and Prevention

The requirement for all departments and locations to have suitable and sufficient violence and aggression risk assessments is currently being promoted by the V&A Case Manager in response to reported V&A incidents. The risk assessments and management information pack have been revised and updated to include further aspects of security in order to safeguard staff and patient safety.

Prevention and Management of Violence and Aggression (PAMOVA) Team

The team have provided expert advice to several departments over the last quarter in different localities.

This advice has included;

- Best interests process;
- Training and advice;
- Safety pod training;
- Advice on transporting detained patients to care homes;
- Nasogastric feeding whilst restrained;
- Support and guidance on person centred support plans.

Reducing Restrictive Practice Training

- There have been 794 places available on training courses, with 364 places being utilised.
- 23 extra courses have been provided when the team have been able to accommodate.
- Bespoke training has been completed by district nurses, school nurses and some older adults' areas, which has resulted in an additional 147 staff being trained.
- There has been a good uptake of staff from the general wards completing the Restraint Reduction in Older Adult Care training, with the majority of courses being full. Cadog ward GGH, Meurig ward BGH, PPH ward 9, PPH ward 1 are some of these wards that have been trained, with excellent feedback at the end of the course.
- The team has re-introduced training for Community Mental Health Teams in all localities, offering the All-Wales Violence and Aggression training Passport.
- Training at Hafan Derwen, Carmarthen can accommodate 12 participants per session.
 The training venue in Pembrokeshire can accommodate 12 participants but
 unfortunately Aberystwyth University have issued formal notice to vacate the training
 room used in Ceredigion by the end of December 2023.

Argymhelliad / Recommendation
