# ADRODDIAD SCAA SBAR REPORT

#### Sefyllfa / Situation

On the 9 February 2022, the National Threat Level set by the Joint Terrorism Analysis Centre (JTAC) was lowered from 'SEVERE' to 'SUBSTANTIAL', meaning an attack is likely. This threat level is still in place.

On the 18 July the UK Government published its updated Counter Terrorism Strategy (CONTEST 2023). This sets out several key developments: a domestic terrorist threat across the UK which is dominated by individuals or small groups acting outside of organised terrorist networks; a threat from Islamist terrorist groups based abroad that is persistent and has evolved; and the accelerating availability of new technologies and online platforms which provides both opportunity and risk to our counter-terrorism efforts.

CONTEST 2023 details how the UK's counter-terrorism response will adapt to the enduring and evolving threat from terrorism. The established CONTEST framework – **Prevent, Pursue, Protect and Prepare** – remains a strong foundation upon which to base our counter-terrorism efforts, and the updated strategy highlights how we will continue to adapt and improve in an agile way across these pillars.

#### Cefndir / Background

This report has been prepared using information provided by Dyfed Powys Police and relates to the activity of PREVENT referrals for the County.

The Dyfed Powys Counter Terrorism Local Profile has not been updated since the previous version was presented to this Committee earlier in 2023. Therefore, this report focusses on the PREVENT activity within our region as well as highlighting changes to the PREVENT Duty.

## What is the PREVENT programme?

The core mission of PREVENT is stopping people from becoming terrorists or supporting terrorism. The early intervention support provided by Prevent addresses the personal, ideological, and social factors which make people more susceptible to radicalisation.


The programme works in partnership with front-line professionals such as teachers, healthcare practitioners, social workers, the police, charities and civil society, psychologists, community leaders and others. It deals with all forms of terrorism, including Islamist, extreme right-wing and a range of emerging threats.

A PREVENT referral can be made by anyone who is concerned that they, or someone they know, is susceptible to radicalisation or might be at risk of becoming involved in terrorism or supporting terrorism. This could be a family member, friend, colleague, or a professional.



## Data from Quarter 2 (July – September 2023)


## Number of Prevent referrals by month




Seven referrals were received in Q2, a slight drop from eight in the previous quarter. Notably no referrals were received in August, likely due to the school Summer holidays. Pembrokeshire provided the majority of referrals this quarter with five (62.5%)



Analysis reveals all referrals were male, and 50% were in the 0-17yr age category.



Counter Terrorism Policing and Schools contributed the majority of referrals in this quarter with two each.



Only three referrals had an identifiable ideology present. Right Wing accounted for two and one Incel. One referral did not have an ideology identified and further clarity is being sought from the originator regarding this.

# PROTECT and PREPARE

#### Martyn's Law

Following the series of stakeholder engagement workshops for Martyn's Law, Home Office officials are now considering the feedback and requests made during the workshops.

Information was provided in terms of thinking around roles and responsibilities, a Competent Person's Scheme and what that might look like, the expectation for testing and exercising of plans for both the standard and enhanced tiers, and the possibility of identifying/developing a capacity calculator that can replace the various different calculators that currently exist (for example Fire Regulations, Health and Safety etc.).

## PREVENT

#### Independent Review of PREVENT

The William Shawcross Independent Review of PREVENT made 34 recommendations that were agreed by the UK Government in February 2023.

The UK Government has committed to implement the majority of recommendations within twelve months, to that end the Welsh Government is continuing to work with Home Office to ensure devolved areas of responsibility are acknowledged.

## PREVENT Duty Guidance Refresh

A key expectation for the healthcare sector is to ensure that healthcare professionals are trained to recognise where a person might be susceptible to becoming radicalised into terrorism, know how to refer someone into PREVENT, and are aware of available programmes to provide support

The Guidance describes the need to have a programme to deliver PREVENT training, in line with guidance from the Home Office and Health Education England and that all relevant healthcare professionals should receive annual updates and three-yearly refresher training.

Currently no formal PREVENT awareness training is being delivered within the Health Board so this is one area that will prove challenging in terms of risk assessing which staff would require training, who would be best placed to deliver it and impact on staff training time.

**Health Board Management and Reporting arrangements for CONTEST**/ PREVENT Health Board discussions are progressing with key stakeholders in relation to Executive portfolios and agreement as to the most appropriate operational leads for this ever increasing and varied agenda.

The commitment to CONTEST incorporates the PREVENT (Channel Panel) element which is primarily represented by the Safeguarding Team. The wider agenda now includes Serious Violence and Organised Crime, Serious Violence Duty, responsibilities under the Protect Duty, Community Safer Partnership. This includes commitment to representing the Health Board at both County and Regional Boards as well as identifying the most appropriate team to deliver or co-ordinate PREVENT awareness training.

It is recognised that a CONTEST/PREVENT Health Board action plan would be beneficial in defining what actions are necessary to comply with the latest guidance and this will be progressed by the Emergency Preparedness, Resilience & Response Group (EPRR).
