ADRODDIAD SCAA SBAR REPORT

Sefyllfa / Situation

This paper updates the Health & Safety Assurance Committee (HSAC) on progress on the Fire Enforcement Notices and Letters of Fire Safety Matters issued by the Mid and West Wales Fire & Rescue Service (MWWFRS) on WGH and GGH.

Cefndir / Background

The MWWFRS, as part of their normal routine inspections, visited WGH on 30th July 2019 and GGH on 24th February 2020, to undertake inspections of Fire Safety. As a result of these inspections, Fire Enforcement Notices and Letters of Fire Safety Matters were issued on the WGH site and a single Fire Enforcement Notice on the GGH site.

As noted in the paper to the September 2020 HSAC meeting, a significant number of actions have already been addressed in meeting the requirements of the Fire Enforcement Notices..

In addition as previously reported, a number of challenges have been identified in delivering the works to achieve the original agreed programme dates.

At WGH these challenges relate to the delays with Welsh Government (WG) endorsement of the Programme Business Case (PBC) and the Building for Wales (BfW) Framework Contractors being unwilling to participate in the tender process.

At GGH the key challenge is in respect of fire survey companies being unable to complete their works within programme due to the impact of COVID-19 restrictions.

The challenges noted above have now been fully considered and revised implementation dates have been identified.

Asesiad / Assessment

The challenges around the BfW Framework Contractors have been embraced by the NHS Wales Shared Services Partnership (NWSSP) and WG. Action has been taken by WG to modify the core contractual pricing arrangements contained within the BfW Framework Contracts. This has involved moving from a Target Price form of contract to one which is based on a Cost Plus form of contract. This change has been developed with NWSSP and WG with full procurement advice to support this change.

This change in contractual arrangement has resulted in three of a possible five Framework Companies agreeing to participate in the process.

Clearly this has had a significant impact on the overall programme as set out later in this report.

As this work is being progressed by NWSSP and WG, HDdUHB has maintained close communications with MWWFRS.

In order to consolidate the assessment of all the impacts on the programme, including delays on PBC endorsement, challenges around Framework Contractors and furloughed survey staff, HDdUHB has developed a revised programme taking into account these factors.

To ensure all parties are fully briefed on this work, HDdUHB facilitated a meeting which took place on 2nd October 2020. This meeting involved Senior Management from WG Capital Teams, NWSSP and Senior Representation from MWWFRS, as well as HDdUHB's Director of Operations.

At this meeting, HDdUHB presented a revised delivery programme for both WGH and GGH, specifically identifying the rationale for any changes made (attached as Appendix 1 and 2), summarised below:

WGH

- Advanced works WG support approved and currently on programme for delivery January 2021.
- Phase 1 –The delivery of this phase of the contract by is now reprogrammed for April 2022. This was previously December 2021.
 This change is due to the delay in the endorsement of the PBC by WG, and the issue around Supply Chain Partner Contractors declining interest in the process. (Note: this is now resolved). HDdUHB is currently funding the fee element of the Business Justification Case in order to maintain this programme.
- ▶ Phase 2 The commencement of these works is now programmed to begin May 2022 as compared to January 2022. It is acknowledged by all parties that substantial further work is needed on this phase to develop an appropriate de-cant and phasing programme. We have estimated this period (subject to further analysis) to be in the order of 2 years from May 2022.

GGH

- Advanced works Now programmed to complete in August 2021 as compared to an original date of May 2021. This delay is primarily due to the impact of COVID-19 on the sub contracted survey company furloughing their staff.
- ▶ Phase 1 Delivery of this phase of the contract by July 2022 as compared to April 2022. The delay is a knock-on effect due to the delay of the survey work noted above.
- ➤ **Phase 2** The commencement of these works is now programmed to commence August 2022 as compared to May 2022. The delay is again a knock-on effect due to the delay of the survey work as noted above. We have estimated this period (subject to further analysis) to be in the order of 2 years from August 2022.

At the meeting, it was beneficial that both WG and MWWFRS were present in order to provide clarity on the revised delivery programme and also outline the rationale for the changes required. WG and NWSSP have been very supportive of the approach taken by HDdUHB and fully understood the Capital requirements of this programme at the various stages of delivery. Similarly, the MWWFRS representatives, the Station Manager, Deputy Head of Fire Safety and Watch Manager, fully understood the reasons for the revisions and have been supportive of the approach taken. They advised that they will brief their Chief Fire Officer and confirmed that they are supportive of the re-programming of the works now established. The Chief Fire Officer will then direct them in terms of the re-issue of revised Notices.

Whilst these revised Notices are still to be received, for assurance, an email has been received from MWWFRS confirming the current status.

The MWWFRS issued a Letter of Fire Safety Matters for GGH which has identified a number of actions required by HDdUHB which they require to be undertaken in line with our Phased investment plans.

A full action plan has already been established to deliver on these requirements to the timelines set and this will be monitored by the Fire Safety Group and within the HDdUHB Fire Tracker managed by the Assurance & Risk Teams.
