ADRODDIAD SCAA SBAR REPORT

Sefyllfa / Situation

The Mental Health Legislation Scrutiny Group is a Sub-Group of the Mental Health Legislation Assurance Committee (MHLAC).

The purpose of this paper is to present the Mental Health Legislation Assurance Committee an update from the Mental Health Legislation Scrutiny Group meeting held on Thursday May 11th 2023.

Cefndir / Background

The following papers are submitted as standing items on the MHLSG agenda in line with the principal duty of the scrutiny group as described within the Terms of Reference alongside any relevant reports or memorandum of understanding

- Mental Health Act Use which includes a SCAMHS update report on admissions to the designated bed on Morlais Ward
- Mental Health Measure performance report
- Three County Local Authority Data
- Quality Assurance and Practice Development Team Paper

Papers are sent out to members of the MHLSG at least seven days in advance of the meeting and members are expected to read all papers to allow for scrutiny and discussion in respect of information provided. Unfortunately, ahead of the May meeting a virus prevented some members of the group having access to all of the papers via email for the meeting. Ahead of the August meeting we will revert to use of postal services to avoid a repeat occurrence.

The May agenda had been rearranged to focus on Local Authority (LA) Data at the beginning of the meeting but unfortunately Pembrokeshire and Ceredigion representatives were absent although reports were submitted. The Chair took an action to address the attendance issue before the next meeting.

The data provided by Ceredigion included use of the S136 in Gorwelion and also when detention under S136 was avoided and an informal assessment undertaken instead, the figures were;

The number of MHAAs that did not require admission as an outcome were only three out of forty two, further exploration of this data would be helpful with respect to these numbers to determine whether the Act was engaged when all informal community options had been exhausted. The figure for S136 detentions in Pembrokeshire was nil due to the centralised place of safety in Carmarthenshire, it will be helpful to understand the impact of this change with regard to Carmarthenshire services although it was not highlighted in the Carmarthenshire report. The presence of the Carmarthenshire LA representative stimulated a helpful debate in relation to the training provided to the police by health and local authority staff. There was a consensus, that in future training should be co-produced with the police, ourselves and West Wales Action on Mental Health (WWAMH) this will be progressed with the force mental health advisor. The other information of note was that one student will attend the Approved Mental Health Professional training course at the University of West England which will enable a comparative evaluation with Swansea University on completion.

Review of Terms of Reference:

The Terms of Reference agenda item was deferred as guidance in respect of the Terms of Reference, the membership of the group and the length of term to be served by members not in substantive roles, will be provided by the Director & Clinical Director & Associate Medical Director for MH&LD, this will also include the term to be served by the Chair and Deputy Chair.

Mental Health Act Report

The data report was circulated by the Mental Health Act Administration lead prior to the meeting. The data was scrutinised and debated at SG and the Mental Health Act Committee report outlines this detail alongside any actions required. This is contained as an appendix to this report and salient points will be presented verbally at Committee by the author.

Measure Report

The Measure data report was presented by the Head of Service for Adult Mental Health and circulated to Scrutiny members ahead of the meeting. The Measure committee report outlines the scrutiny and any actions allocated by MHLSG. This is contained as an appendix and salient points will be presented verbally at Committee by the author.

Quality Assurance and Practice Development (QAPD) Report

Prior to the meeting, the QAPD report was circulated to enable members to read the content. The report highlighted the Care and Treatment Plan Audit outcomes for Quarter four which included

information on the sample audits that are being conducted to ensure required standards of quality are adhered to. The attainment of CTP standards are fairly constant and overall the quality is reasonably good in terms of having the necessary information in the correct domains.

Regarding Part One of the Measure, the audit outcomes demonstrated variability in respect of engagement which requires a process to ensure all teams provide data. A recent Health Inspectorate Wales Improvement Plan relating to another Health Board requires all Health Boards to review services against the recommendations issued which will assist the Directorate to improve Part One reporting processes.

The QAPD team continue to undertake Healthy Ward Checks with positive learning outcomes. The team are now looking to developing a similar process for the Community teams. The inclusion of persons with lived experiences and carers was raised at the meeting as this was the arrangement previously, the Senior Nurse for QAPD will reinstate this.

Policies

The Sec 5(4) nurses holding power policy and the Independent Mental Health Advocacy (IMHA) Policy were circulated to the group for comment following the meeting.

Out of Area Patients Governance and Assurance Process:

This is on the agenda for August 2023, the meeting will be attended by the Head of Service and the Senior Nurse from Commissioning with out of area data provided ahead of the meeting as well as a revised Community Mental Health Team matrix to identify the numbers of Relevant Patients per CMHT placed out of area.
