# What is the aim of the Planning Objective?

#### **Aims and Outcomes:**

Deliver priority actions associated with the third year of the Research and Innovation (R&I) Strategy (2021-2024) and associated TriTech Business Plan. Eight priority actions were agreed for 2023/24.

### **Intended Impact:**

Our Research and Innovation Strategy (2021 – 2024) committed to four goals: improve the quality and impact of activities; invest in staff and facilities, encouraging a virtuous funding cycle; grow research and innovation activity in areas of strength and opportunity; develop effective partnerships with academic, healthcare, industry and research organisations. This year's eight actions will ensure the overall delivery of the strategy.

#### **Drivers:**

To produce and collaborate in high quality health and care research and innovation, to improve services and health outcomes for our public, patients, and staff.

### **Connections to Ministerial or Local priorities:**

Research into diseases, treatments, and services can lead to discoveries and innovations that improve patient outcomes and save lives. A large body of evidence associates high levels of research and innovation activity with higher employee engagement and satisfaction and improved care quality. The written statement on Ministerial priorities calls out innovation as being an important supporting function to the 'delivery of optimum care and services for patients, alongside workforce, wellbeing, and robust financial management'.

## What needs to be done next?

- HCRW Funding: Prioritise securing adequate funding from WG via HCRW for Research Delivery across all locality sites
  and teams for 2024/2025. Funding was decreased by 4.7% in 2023/2024, in view of national pressures. Should
  Research Delivery funding decrease for a second consecutive year, we may need to amend our strategy and operating
  model.
- Facilities: Work with the site team to determine the timeline for providing 'fit for purpose' facilities for the WGH Research Delivery Team and increase research participant recruitment at this site.
- Oncology research: Develop a plan with HCRW, other health boards and stakeholders to overcome the barriers to develop a regional approach to oncology research, ensuring that patients in South-West Wales have equitable access to cancer studies.
- Increase research active clinician numbers: Ensure applications are submitted and funding is secured from the new HCRW faculty award schemes.
- TriTech Business plan: commence work on 24/25 business plan delivery.
- **TriTech Expansion:** Meet with Health Boards that have demonstrated an interest and, if appropriate, develop a case for consideration by Executive Team and the Health Board.





# What are your take home messages for the Committee?

- We are on track to deliver our 2021-24 strategy.
- Our recent HCRW performance review and feedback was positive. The areas within our annual plan have national support.
- TriTech and Innovation continue to be referenced as an exemplar and delivery has met all planning assumptions. Interest expressed by other NHS organisations in developing a similar model.
- Just like all areas of the NHS, the financial position for R&I is challenging and national decisions <u>may</u> result in a strategic and workforce review.
- The PODCC is asked for its continued support in relation to the eight action areas for the R&I annual plan.
