Sefyllfa / Situation

With the arrival of a number of effective vaccines for COVID-19, Hywel Dda University Health Board (HDdUHB) has developed a Mass Vaccination Programme Delivery Plan. The latest iteration of this plan (at time of writing) has been signed off by our Tactical Group and is being implemented by our Bronze Vaccination Delivery Group. The Plan is attached to this SBAR for information and assurance.

Cefndir / Background

The COVID-19 pandemic has been with us now since early 2020 and we have seen it impact every area of our personal and professional lives. Our hospitals and staff across HDdUHB have risen to the enormous challenges it brings with professionalism, determination, tenacity and kindness. There have been difficult times and moments when our health care services have come under extreme pressure. We have also seen far too many deaths, every one a tragedy for their loved ones and the staff who cared for them.

Vaccines offer a hope that we can see an end to this pandemic and the impact it has had on our lives. The news of the first to receive regulatory approval was communicated in early December 2020 and by the 8th of that month, we had given our first dose to a member of our front line health team.

Since then, supplies have increased and further vaccines have been approved for use. The attached Plan, correct at time of writing, sets out the way in which we have, and will continue, to roll out our local programme. It is being implemented and constantly updated through our existing command and control arrangements.
