ADRODDIAD SCAA SBAR REPORT

Sefyllfa / Situation

The performance report incorporates COVID-19 elements and focuses primarily on Hywel Dda University Health Board's (HDdUHB) key deliverable areas. As in previous months, this report is being brought to the People, Planning and Performance Assurance Committee's (PPPAC) attention to examine and consider HDdUHB's latest available performance data, achievements, risks, impact and actions during the COVID-19 pandemic. This update consists of:

- Executive summary.
- COVID-19 one page summary of key points.
- Key performance areas overview.
- Essential service update a one page summary of services maintaining Welsh Government (WG) operating framework compliance.
- Themed updates for key deliverables.

Asesiad / Assessment


Key points to highlight in relation to this month's IPAR are:

• **Unscheduled care** – the overall performance trend for the four unscheduled care metrics is declining. In November 2020, red calls reported the poorest performance since October 2015.

 Planned care – breaches for referral to treatment (RTT) within 36 weeks have increased for the 8th consecutive month from 722 in March 2020 to 25,785 in November 2020. We are continuing to work with the Informatics Department on the risk stratification of the waiting lists which will be shared once complete. The Chief Executives in Wales have requested a full review of patient volumes waiting over 36 weeks and projected recovery times; this data is currently being updated.

 Neurodevelopment and Psychological services – as at 31st October 2020, there were 1,166 children waiting over 26 weeks for a neurodevelopment assessment and 1,206 adults waiting over 26 weeks for a psychological therapy.

Cancer

- During October 2020, 78 out of 113 (69%) urgent suspected cancer patients commenced treatment within 62 days, considerably below the 95% target. The requirement for cancer patients to self-isolate pre-treatment continues to impact on performance across Wales.
- The 98% target was achieved for non-urgent suspected cancer patients (99%).

• **Diagnostics and therapies** – improvements continued to be made in November 2020 to reduce breaches for diagnostic waits (5,288 compared to 7,669 in May 2020). Therapy waits have been consistently reducing each month, from 1,613 in June 2020 to 463 in November 2020.

Stroke

- The percentage of patients admitted to a stroke unit within 4 hours has improved across 3 of our sites this month. Bronglais General Hospital (BGH) has consistently met the target of 54%. Withybush General Hospital (WGH) declined from 64.3% in October 2020 to 52.4% in November 2020. Over the last 12 months, Glangwili General Hospital (GGH) has repeatedly fallen below target; although improvement was seen in November 2020 only 15.4% performance was achieved.
- The target for stroke patients to be seen within 24 hours by a stroke consultant has been consistently met throughout the COVID-19 pandemic.
- Healthcare acquired infections (HCAI) the targets have not been met for Clostridioides difficile (C.difficile), Escherichia coli (E.coli) and Staphylococcus aureus (S. aureus). However, when compared to the same period in 2019/20, year-to-date improvements have been made: C.difficile cases reduced by 12%, E.coli cases reduced by 23% and S.aureus cases reduced by 24%.

As previously documented, the recording and monitoring of data for all areas is continuing bar: substance misuse, deaths scrutinised by an independent medical examiner, hip fractures, carbon monoxide (CO) validation for smoking cessation, hospital acquired thrombosis and some Mental Health Act measures. Work is ongoing to address these data gaps.
