SBAR REPORT

Sefyllfa / Situation

This report provides an update on the activities of the 'A Regional Collaboration for Health' (ARCH) Portfolio from March 2020 to July 2020. It also provides an update on the regional discussions that have taken place between Hywel Dda University Health Board (HDdUHB) and Swansea Bay University Health Board (SBUHB) in July 2020.

The People, Planning and Performance Assurance Committee (PPAC) is asked to note the content of the report.

Cefndir / Background

The ARCH Service Transformation Group has not met since 5th March 2020, and all Clinical Service projects were put on hold during the COVID-19 period. In the last month, however an informal HDdUHB and SBUHB regional meeting took place on 7th July 2020 to discuss regional matters relating to strategic change and the COVID-19 response. The main issues that were discussed are summarised below.

Asesiad / Assessment

HDdUHB and SBUHB Regional Meeting

- **Essential services** (as defined by the Operational Framework for COVID-19 by Welsh Government (WG):
 - Discussions have focussed on urgent & cancer priorities, and opportunities for routine elective volumes are currently being scoped. Opportunities for regional urology access to Werndale Hospital are under review.
 - The outcome of national discussions, led by NHS Collaborative to establish regional endoscopy service centres is awaited and regional discussions will be undertaken as appropriate.
 - Wales Cancer Network has invited all health boards to develop a regional demand and capacity model. HDdUHB's Project Group established to consider model and learning from a pilot at Neath Port Talbot Hospital for regional/virtual support opportunities.

- **Sharing Strategic Change Plans** – SBUHB gave an update on the work around the Acute Medical Services Redesign and the plans to explore using Neath Port Talbot Hospital site as an Orthopaedics Centre.
- **Field Hospitals** – discussions have taken place on whether there is any potential for regional opportunities, including a regional workforce model. The HDdUHB Field Hospital roll out contingency/surge plan is set out within the Quarter 2 Operational Framework response submitted to WG in July 2020.
- **Digital**– it was agreed that the Digital Teams in both health boards develop their modelling capabilities in response to the pandemic. It was agreed to share the learning on demand/capacity modelling.
- **Regional Computerised Tomography (CT) Scanner** – it had been agreed that there would be a regional CT scanner sited at Glangwili Hospital, Carmarthen, in Quarter 2 and the operational teams would meet to agree how this would be utilised.
- **ARCH Service Transformation** – this is described in further detail below.

ARCH

- **Eye Care** – a joint workshop between the two health boards was held on 24th July 2020, where it was agreed to prioritise the glaucoma pathway (joint appointment) and establish sub-specialty review groups. A longer-term model for a Regional Specialist Centre is to be explored.
- **Dermatology** - a planning workshop was held pre-COVID-19, and a comprehensive regional work plan was agreed in March 2020. This is currently being reviewed and the focus will be on recruitment to key posts to support service sustainability.
- **Neurology** – during the COVID-19 period, clinical teams were required to be innovative in delivering care, seeing patients and families remotely, holding groups remotely, undertaking webinars and developing a support website. These important lessons learnt are being incorporated into the the business case for Functional Neurological Disorders.
- **Research, Enterprise and Innovation** – during the COVID-19 period, work has continued in a number of key areas including:
 - **The ARCH Innovation Forum** was launched in July 2020. The Innovation Forum is being established to provide guidance, advice, support and signposting from a multi-disciplinary stakeholder group to innovation projects from across the region. The purpose of the forum is to accelerate innovation across the health and care sector to improve the health, wealth and wellbeing of South West Wales. An invitation for expressions of interest to present innovation projects to the panel was distributed across the health boards, academia and industry with a closing date of 24th July 2020, with an inaugural forum to be scheduled for selected participants to present to an appointed expert panel.
 - Swansea University hosted a ‘**Celebrating Medical Innovation**’ webinar to celebrate the outstanding examples of innovation across the region. Keynote speakers, including Dr Richard Evans (SBUHB), Professor Keith Lloyd (Swansea University) and Debbie Laubach (MediWales), were followed by case studies of innovation projects that were undertaken in efforts to support the COVID-19 pandemic. These included the development of a rapid manufacture emergency ventilator in a project supported by Swansea University, University of Wales Trinity Saint David, Accelerate, Astute 2020, Industry Partners, Welsh Government and NHS Wales and the local manufacture of certified approved visors in a collaboration between Swansea University, Accelerate Healthcare Technology Centre, Astute 2020 and industry partners. The event attracted over 100 delegates and positive feedback and engagement has been received following the event.
 - **The Healthcare Technology Centre**, as part of Accelerate and embedded within the Institute of Life Sciences at Swansea University, has been continuing to support activity during the pandemic. The teams have been supporting a number of

collaborative innovation projects to support the public, patients, NHS and population during the COVID-19 pandemic. Accelerate has secured funding from the European Regional Development Fund until 2022. Further information can be found via the links below:

- Both Health Board Research and Developments teams have been prioritising COVID-19 related studies and are supporting a number of nationally prioritised studies as well as local innovation projects.
- **An NHS Innovation Leads Group** has been established with representation from both health boards.
- **Swansea Bay City Deal Campuses Project** is making progress with business planning processes advancing and submission of the outline business case to the City Deal Regional Office for review anticipated in Quarter 3 2020.
- **AgorIP** – a planned extension until 2023 is being arranged, building upon existing projects including activities across ARCH such as health board secondments, work through Innovation Leads developing aligned IP (Intellectual Property) Commercialisation Framework, tools and structures.
- **Intensive Learning Academies** – a proposal to establish an Intensive Learning Academy in Value-based health and social care and Innovation, has been submitted, and is subject to final business case stage by WG. This has been supported by the Health Technology Centre (Swansea University) and wider ARCH stakeholders.
