ADRODDIAD SCAA SBAR REPORT Sefyllfa / Situation

The performance report incorporates COVID-19 elements and focuses primarily on our key deliverable areas. As in previous months, this report is being brought to the People, Planning and Performance Assurance Committee's (PPPAC) attention to examine and consider Hywel Dda University Health Board's (HDdUHB) latest available performance data, achievements, risks, impact and actions during the COVID-19 pandemic. This update consists of:

- Executive summary.
- COVID-19 one page summary of key points.
- Key performance areas overview.
- Essential service update a one page summary of services maintaining Welsh Government (WG) operating framework compliance.
- Themed updates for key deliverables.


Cefndir / Background

The interim <u>NHS Wales Delivery Framework 20/21</u> (https://hduhb.nhs.wales/aboutus/performance-targets/performance-documents/2020-21-delivery-framework) published in May 2020 has migrated and modelled on 'A Healthier Wales' quadruple aims as part of the 'Single Integrated Outcomes Framework for Health and Social Care'.

Asesiad / Assessment

Six key points to highlight in relation to this month's IPAR are:

 Unscheduled care – red calls performance has declined for the third consecutive month, with September 2020 reported at 50.6% (see chart below) which is our poorest performance since records began in October 2015. All three local authority areas missed target (65%): Carmarthenshire 49.2%, Ceredigion 50.0% and Pembrokeshire 52.8%. However, October 2020's provisional performance is looking to have improved (62.1% as at 18th October 2020).



The other three unscheduled care metrics have also reported a continued deterioration in performance during September 2020:

• **Stroke** – patients admitted to a stroke unit within 4 hours has also deteriorated for the 3rd consecutive month (55.4% in September 2020 against a 54% target). However, the target for stroke patients to be seen within 24 hours by a stroke consultant has been consistently met throughout the COVID-19 pandemic.

Cancer

- During August 2020, 72 out of 87 (82.8%) urgent suspected cancer patients commenced treatment within 62 days, which is below the 95% target and a 3% reduction from July 2020. The requirement for cancer patients to self-isolate has impacted on performance across Wales.
- However, the 98% target was met for non-urgent suspected cancer patients (98.7%) and there was a 2% improvement in patients on the single cancer pathway being treated within 62 days of the point of suspicion.
- **Planned care** referral to treatment within 36 week breaches have increased for the 6th consecutive month from 722 in March 2020 to 17,857 in September 2020. The specialties with the highest numbers of breaches are:

- **Diagnostics and therapies** improvements continued to be made in September 2020 to reduce breaches for diagnostic waits (5,918 compared to 7,669 in May 2020) and therapy waits (793 compared to 1,613 in June 2020).
- **Job planning** as at 30th September 2020, only 36% of consultants and SAS (staff grade, associate specialist and specialty) doctors had an up-to-date job plan.

As previously documented, during the pandemic we continue to record and monitor data for all areas, bar five exceptions: substance misuse, deaths scrutinised by an independent medical examiner, hip fractures, carbon monoxide (CO) validation for smoking cessation and some Mental Health Act measures. Work is ongoing to address these data gaps.
