Update from Sian-Marie James: 21 February 2024 Legal & Risk has advised that the first draft of the ARCH MoU will be provided by 1 March 2024. Update from Sian-Marie James: 11 December 2023 On 4 December 2023, the ARCH Regional Recovery Group supported the proposal for developing a regional (ARCH) MoU. Colleagues are now discussing the clauses to be included in this document. Update from Sian-Marie James: October 2023 Following internal discussions and meetings with ARCH colleagues, the Health Board is considering entering into an overarching Memorandum of Understanding with

				Swansea Bay UHB (and possibly Swansea University) in relation to ARCH programmes of work. Internal discussions are continuing. If this is agreed, the MoU would include all programmes, including Orthopaedics. The Project Definition Document (PDD) for regional Orthopaedic services between the Health Board and Swansea Bay UHB is a separate document. <b>June 2023:</b> The Memorandum of Understanding (MoU) and supporting Project Definition Document (PDD) has been referred to the ARCH Regional Recovery Group. The CEOs are due to meet to agree the project leadership arrangements and details of the proposed governance structure before presentation to Board for formal adoption. <b>JW to follow up with KJ.</b> <b>Update from Keith Jones: August 2023</b> The ARCH Regional Recovery Group meeting for July 2023 was cancelled and the Group is not due to meet again until September 2023, at which time the MoU will be discussed further.
