ADRODDIAD SCAA SBAR REPORT

Sefyllfa / Situation

This report provides an update on the activities of the ARCH Portfolio and the regional discussions held between Hywel Dda University Health Board (HDdUHB), Swansea Bay University Health Board (SBUHB) and Swansea University for the period April to May 2022.

Cefndir / Background

Headline discussions and issues taken to ARCH groups are summarised in this report:

- ARCH Regional Recovery Group (RRG) Chaired by Steve Moore
- ARCH Strategic Developments Group (SDG) Chaired by Lee Davies
- ARCH Operational Change Groups (OCG) Chaired by Andrew Carruthers

Asesiad / Assessment

ARCH currently has six programmes of work:

- Cardiology Regional Services
- Regional Eye Care
- Dermatology Regional Services
- Neurological Conditions Regional Services
- Pathology Regional Services
- South West Wales Cancer Centre (SWWCC) Services

and five emerging programmes of work:

- Hyper Acute Stroke Unit (HASU)
- Orthopaedics
- Endoscopy
- Radiology
- Oral Maxillofacial Surgery (OMFS)

Cardiology Regional Services

- Operational groups have worked with the Wales Cardiac Network and Finance Delivery Unit to agree an Acute Coronary Syndrome (ACS) pathway across the region. A proposal was endorsed by the RRG in March 2022. Updates were provided and agreed in May 2022. Work underway includes reducing the admission time to referral to the Centre in HDdUHB, reinstatement of the Treat and Repatriate service and the ring fencing of regional beds at Morriston.
- Assisted Reality in Echocardiography has received £35k funding to develop a tool that supports training, mentoring and second opinion at a distance for Echocardiography. This is achieved by the use of a ruggedized assisted reality solution camera mounted on a headset and the development of some bespoke software for use on an eye level micro display. This work started in April 2022.

Regional Eye Care

- An update to the South West Wales (SWW) Glaucoma Service business case for introducing the Ophthalmic Diagnostic and Treatment Centre model of care across the region highlighting revisions to delivery and timelines was received and discussed in March.
- It was agreed at OCG that work on long term plan for eye care would start in October 2022. This would allow time for the short/medium term service changes to embed ahead of future planning.

Dermatology Regional Services

 Regional Dermatology service updates were received and noted via highlight reports without discussion.

Neurological Conditions Regional Services

 The Functional Neurological Disorder (FND) Business Case was endorsed by the RRG in March 2022. This was on the basis that Neurologist Consultant recruitment. Work plans and funding would be linked to joint work between HDdUHB and SBUHB moving towards HASU standards for stroke. Further work is needed to agree step by step investment and service alignment.

Pathology

- Welsh Government led a Gateway Review of the Pathology Programme in late March 2022. The programme received an Amber rating, which is positive for large projects at this stage of development. The Gateway Review made a number of recommendations that the programme is acting upon.
- The Pathology Task and Finish Group will fast track operational issues that require immediate/rapid solution and which are inhibitors to the planning/progress of the Project or are presenting as high risk.
- Work Stream Groups have been established for Microbiology, Cellular Pathology, Laboratory Medicine & Blood Sciences, and Genomics. The first meetings were held throughout April/May 2022. Terms of Reference are nearing completion.
- A workshop reached a consensus to include Laboratory Medicine & Blood Sciences within the Outline Business Case (OBC). Formal inclusion will need RRG and Health

Board agreement. A paper is being prepared to highlight any risks that may impact the timeline/budget.

- Establishing a Research and Innovation workstream is in discussion, this Group's objective would be to maximise research and innovation opportunities from the Pathology Programme and ensure latest and emerging research and technology informs the new service's design.
- The programme's approach/method to service re-design was very well received by the Cellular Pathology workstream as a suitable approach for all workstream redesign.
- ARCH co-ordinated a collective (HDdUHB, SBUHB and Swansea University) response to Wales Genomics Partnership (sent Thursday, 19th May 2022) – the response was circulated on Friday, 20th May 2022 to all ARCH Boards/Groups to note.
- Future Governance Options/Management Structure Report is being prepared to reflect Welsh Government Gateway Review recommendations.
- A Memorandum of Understanding (MoU) setting out the regional working arrangements for Cellular Pathology has been drafted and agreed. Final approval is being sought from HDdUHB.
- A Programme Director role (Gateway Review recommendation) is currently with job matching and will be advertised shortly.
- The workstreams have leveraged support from the Delivery Unit for Pathology demand and capacity modelling which aligns to the work the NHS Collaborative have procured the Delivery Unit to conduct.

South West Wales Cancer Centre (SWWCC) Services

ARCH Strategic Developments Group:

- Approved the recommendation from the SWWCC Regional Strategic Programme to change the programme output to: Develop a Strategic Programme Case
- Agreed the proposed timelines: To submit the Strategic Programme Case to Health Boards in September/October 2022
- Noted the new ask from Welsh Government to provide a 10 year Radiotherapy (RT) Infrastructure Plan in June 2022
- Noted the work in progress to allow the SDG to receive the 10 year RT Infrastructure Plan for approval at the next meeting (24th June 2022);

Emerging Programmes

Opportunities for regional working are being explored by the ARCH NHS Groups for regional HASU, Orthopaedics, Endoscopy, Radiology, and Oral Maxillofacial Surgery (OMFS).

Workshops and discussions have taken place during April/May 2022 to progress these emerging programmes. Papers seeking agreement to formally progress HASU, Endoscopy and Radiology are scheduled for discussion at the RRG in June 2022. A formal update from the national programme for Orthopaedics is scheduled for July 2022, which may lead to a new regional orthopaedics programme. An OMFS paper is expected to follow in September.
