

WHAT

- A review of the of academic literature, based on term 'A Social Model for Health and Wellbeing'
- Undertaken by Aberystwyth University, School of Psychology, with input from the Graduate school and School of Management and Business

WHY

- To provide a solid evidence base for the Health Board and partners to make strategic and operational changes
- To provide a mutual learning resource for all interested parties, on the wider influences on a health system
- To learn from what is written and identify the gaps and opportunities for our future developments.

- Report due June 2022

"Conversations with a purpose"

- 20 semi-structured conversations taken place with 22 senior thought and opinion leaders across society
- Public Health Wales (PHW) have undertaken 1st stage of thematic analysis of the insights and perspectives, with final report due by June 2022
- 18th February 2022 Engagement meeting with Chairs, Vice Chairs and Officers of Public Services Boards (PSBs), Regional Partnership Board (RPB) and Hywel Dda University Health Boar (HDdUHB)
- June 2022 joint PSB, RPB membership meeting in planning to share findings of academic literature review and PHW analysis, to help inform the work and the PSB Wellbeing plans due to be published in Q2 2022
- 1ST April 2022 Transformation Steering Group (TSG) presentation of early learning and agreement to 1st new planning objective from this work based on initial findings. This will be focussed on action supporting local community leadership and their ideas that they believe will have the largest population health & well-being impact in those communities, and exploration of resourcing mechanisms



"Create and implement a process in partnership with local authorities, PSBs and other stakeholders that engages and involves representatives of every aspect of the food system. This will include growers, producers, distributors, sellers, those involved in preparation and the provision of advice to individuals & organisations and thought leaders in this field. The aim is to identify opportunities to optimise the food system as a key determinant of wellbeing. The opportunities identified will then need to be developed into proposed planning objectives for the Board and local partners for implementation from April 2023 at the latest"









4.N – Food System for Wellbeing – Progress to date.

Food Systems Feasibility Study

- December 2022 "North Star Transition" (NST) in partnership with University College London (UCL) Climate Action Unit was commissioned by the HDdUHB to produce a feasibility study on the food system.
- The aim of the four-month-long study was to support Hywel Dda objective of developing an organisational Planning Objective around the food system.
- The approach was based on researching and developing an understanding of the food system that Hywel Dda participates in, and by identifying the system stakeholders, and their views.
- An addition output was to layout a blueprint for engaging with multiple stakeholders to enable the health board to create systems that support wellbeing, through the its relationship with food.
- A draft report was received in March 2022, and is in the process of being scrutinised by colleagues, prior to formal feedback being shared with NST.
- The report gives options to consider for the next steps of developing a long-term planning objective.
- HDdUHB continues to participate in the Wales Transition Hub, facilitated by NST. The work being undertaken by the HB has been showcased through the partnership across Wales and beyond
- It is planned to share the findings with at the PSB / RPB membership engagement event in June 2022 to help inform the 10/12 work and the development of the PSB Well-being plans
