ADRODDIAD SCAA SBAR REPORT Sefyllfa / Situation

This report provides an update on the activities of the ARCH Portfolio and the regional discussions held between Hywel Dda University Health Board (HDdUHB) and Swansea Bay University Health Board (SBUHB) for the period March to May 2023.

Cefndir / Background

The primary issues discussed at ARCH Partnership and progress of the ARCH Service Transformation Programmes are summarised in this report.

The ARCH NHS Regional Recovery Group met on 23 March, 22 April, and 24 May 2023.

Asesiad / Assessment

ARCH Service Transformation Programme Updates

Cardiology Regional Services

- Sessional time to continue the Regional Cardiac Computerised Tomography (CT) service was agreed to maintain current Hywel Dda service levels.
- ACS Pathway business case continues to be refined with Swansea Bay.
- Treat and repatriate service to support the Acute coronary syndromes (ACS) pathway reinstated 26 April 2023. Initial data showing improvements in access to Cardiac Centre by reducing lengths of stay by 1 day. Further improvements are planned.
- Ongoing review of cardiac pacing data produced for 2022/23 to assess whether Hywel Dda needs a long term agreement with Swansea Bay for non-complex pacing.

Regional Neurosciences Services

- Work to develop plans for a Single Neurosciences service was endorsed by the ARCH Regional Recovery Group to achieve greater regional service equity for patients.
- Hywel Dda have committed funding to developing and delivering a Functional Neurological Disorders (FND) service. Currently wating for confirmation of funding from Swansea Bay ahead of recruitment.

- Collaborative working between health boards has commenced in a move towards a regional Neurophysiology service, linked to the single neurosciences highlighted above.

Regional Diagnostics

- The initial Regional Diagnostics Programme Board met on 10 May 2023 with the meeting being chaired by Mark Hackett, CEO Swansea Bay, and well attended by Clinical Leaders of Radiology, Endoscopy, Cardiology, Pathology and Neurology. Also in attendance were Executive Directors from both Health Boards who will be responsible for supporting delivery of the programme.
- Key areas of discussion and agreement were:
 - Scope of programme agreed to be all diagnostics from Community to Tertiary, ensuring the continuum of care for each patient is included.
 - Terms of Reference (ToRs) were presented and comments offered with agreement expected at next meeting. Programme Board meetings scheduled to be every 6 weeks
 - Membership to include Primary Care representatives.
 - Agreed that a definition was required to describe community diagnostics and define any core components.
 - Agreed there should be a common approach and methodology to data capture.
 - All Board Members were tasked with feeding back on strengths, weaknesses and workforce development opportunities of a regional approach to diagnostics.

Regional Dermatology Services

- The all-Wales Teledermoscopy model has now been fully implemented across the ARCH region. There are plans for each Health Board to scale up when consultant capacity, accommodation and administrative support allow.
- A group has been established from May 2023 to support the training and development of HDdUHB Speciality Doctors by Swansea Bay Consultant Dermatologists.

Regional Eye Care Services

- The re-design of the South West Wales Glaucoma Service Business Case is underway and meetings have been set up with individual Health Board Operational Teams to ensure an accurate picture of revised data and projections is included. The timeline for completion and approval is September 2023.
- The work streams for both the Diabetic Retinopathy Referral Scheme and the Cataracts have both concluded.

Regional Pathology Services

- Replacement Programme Manager appointed, commenced in post 2 May 2023.
- Site visits to exemplar laboratory's took place in March 2024.
- 3 stage design workshops held with User Groups from Hywel Dda, Swansea Bay Health Boards and Public Health Wales during April and May 2023. This will confirm Royal Institute of British Architects (RIBA) Stage 2 design for detailed outline business case (OBC) costing and development to be completed.
- OBC development continued with benefits workshops underway, revenue considerations and detailed workforce planning underway.
- Operational Delivery Network (ODN) Transition Board formed, and work programme established. Aim for Shadow ODN from January 2024, full implementation from April 2024.

South West Wales Regional Cancer Services

- SWWCC Strategic Programme Case (SPC) was approved in January 2023 by SBUHB and HDdUHB Boards. The SPC:
 - Provides the 10 year strategic framework for regional radiotherapy and oncology outpatient services (23/24 32/33).

- Provides a framework to develop further business cases and service plans to ensure that all patients across the region receive equitable access to, and outcomes from oncology treatments and services.
- Health Boards committed to the principle of supporting the required revenue costs associated with implementation, on a proportionate share, subject to individual business case approvals.
- Intention to continue work is described in both Hywel Dda and Swansea Bay Health Boards Annual Plans for 2023/24.
- Work has begun on the financial and capital elements with regards to the provision of a second CT Simulator.

South West Wales Regional Stroke Programme

- Comprehensive Regional Stroke Centre (CRSC) (formerly known as Hyper Acute Stroke Unit) Business Case was endorsed by the ARCH Regional Recovery Group in March 2023.
- Hywel Dda UHB and Swansea Bay UHB requested that further work be completed ahead of final agreement.
 - Hywel Dda UHB requested a business case to understand the effects of the CRSC on the Carmarthenshire Stroke Pathway, including changes to the 'National Clinical Guidelines for Stroke for the UK and Ireland 2023'. Details are covered in the Stroke Business Cases that are on the SDODC agenda 26 June 2023.
 - Swansea Bay UHB asked for a redesign and re-phasing of delivery to reflect 2023/2025.

Regional Oral Maxillofacial Surgery (OMFS) Programme

- Workshop with clinical and operational teams held on 26 May 2023. One of a series of workshops that will lead to a regional OMFS work programme and plan.

ARCH Partnership

- The ARCH Partnership met in May 2023.
- ARCH Partnership noted that discussions are ongoing with the Executive Teams in HDdUHB and SBUHB to address challenges in resourcing and prioritising ARCH NHS service transformation programmes.
- An Annual Review 2022-23 is currently being drafted and will be circulated in early June 2023.
- ARCH Partnership received an update about:
 - ARCH Innovation and Research Strategy that encompasses the research and innovation priorities of each ARCH Partner organisation and align to national strategies.
 - Swansea Bay City Deal Campuses project and progress on planning for the Morriston access route.
 - ARCH collaboration with Swansea University to procure a 'market analysis' to support and inform strategic planning and decision making for Campuses project Phase 2 and broader strategic initiatives in research, enterprise and innovation. This would include developing insights into the academic case, clinical case, investor case, developer case, and industry case.
 - ARCH Health Needs Assessment and Health Impact Assessment project will evidence a benefits and impacts baseline Campuses Project and inform strategic planning and decision making for the Swansea Bay City Deal Campuses Project Phase 2.
- The ARCH Partnership endorsed the ToRs (which had been scheduled for review) without amendment.
- Noted that Swansea Bay would fund a second cohort of the ARCH Senior Leaders Development Programme.

ARCH Delivery Leadership Group

The ARCH Delivery Leadership Group met on 1 March 2023 and received and discussed progress updates:
