#### Capital Resource Limit 2021/22

The current CRL for 2021/22 has been issued with the following allocations:

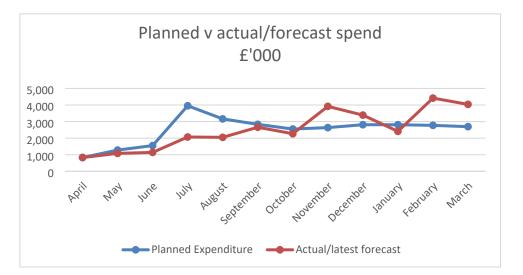
Since the previous report to the Committee in June 2021, AWCP funding has been received for the Fire Compliance scheme at Withybush Hospital. The scheme involves improvement works at the hospital in response to enforcement notices issued by the Fire Service, which are required to be addressed within a defined timescale.

Recurrent revenue costs are not anticipated to arise from the scheme.

Capital charges for depreciation and impairment will be fully funded by Welsh Government (WG) in line with other capital charges.

#### Expenditure profile forecast

The graph below illustrates performance of actual / forecast versus original planned spend.



The graph shows actual spend to Month 4 and current forecast spend profile in red, against the original profile estimate from Month 1. The Month 1 forecast was based to a large degree on estimation as accurate cashflow information on the capital programme is not available at the start of the financial year. This accounts for the difference between the original forecast for July 2021 and actual spend rather than any genuine significant slippage.

The spikes in November 2021 and February 2022 are primarily due to the expected delivery dates for the computerised tomography (CT) scanners at Glangwili General Hospital (GGH) and Withybush General Hospital (WGH), respectively.

As in previous years, expenditure is weighted towards the end of the year, which increases the risks in delivering against the CRL. To mitigate this risk, regular monthly meetings are being held between Finance and principal project leaders and the Estates team, with the aim of identifying slippages at the earliest opportunity to facilitate corrective action and reprioritisation, and to improve general information exchange.

#### Capital Scheme Updates (Schemes greater than £1million) Women & Children's Phase II

There remains a significant delay to the project with an anticipated completion date of September 2022. Risks to the handover of phase 2 by the end of July 2021 were discussed at the most recent project meetings and actions to mitigate these risks were accepted by the Project Board. However, handover was not achieved due to unresolved defects and therefore, the project meetings being held in August 2021 will discuss options available to resolve and achieve handover.

## WGH Magnetic Resonance Imaging (MRI) Scanner Replacement

Following scheme slippage from the previous financial year into the current financial year, the MRI scanner was delivered in July 2021. Installation is currently in progress with the anticipation that the scanner will be operational from mid-August 2022.

## **National Programmes**

The project to deliver additional CT scanner facilities at GGH and WGH is currently at the design stage. The project team are not currently reporting any risks to delivery. The Estates Advisory Board funding is for numerous smaller schemes, which are mainly at the design/tender stage.

# WGH Fire Compliance Work

WGH Fire Compliance work commenced on site in June 2021 and is currently progressing with no risks flagged regarding delivery. A cashflow forecast for the year has been provided by the project Cost Adviser against which progress will be monitored.

# Women & Children Phase II (GGH)

There is an estimated additional cost implication of £1.920m for the scheme due to the implementation of social distancing legislation as a consequence of COVID-19. These costs have not yet been agreed with the Supply Chain Partner. Following review of these additional costs by NHS Wales Shared Services Partnership (NWSSP)-Estates, they have agreed that the additional costs are reasonable and have advised WG as such. WG have confirmed that their policy is to fund COVID-19 related costs.
