Secondary Care and biosimilar drugs improvements to reduce run rate. An update	
was given around delivery of savings linked to the switch where appropriate to biosimilar	
drugs.	
Transformation of Urgent and Emergency Care and the savings impacts. An initial	
discussion has taken place regarding the impact which can be expected on beds and	
therefore agency staffing, it was agreed a further session will be arranged shortly.	
 Bed configuration 25B and 25A selected areas (Accident and Emergency, Clinical 	
Decision Unit and Minor Injuries Unit) leading into reduced agency usage. A group	
will be established to identify whether the Pembrokeshire bed model could be replicated	
by using Community Hospitals differently. It was recognised this work needed central	
support to ensure the potential model could be developed at pace.	
Recovery Plans Radiology – the current challenges impacting on the recovery plan	
were highlighted which were predominantly linked with service demand. Actions to	
reduce agency reliance were discussed therefore, whilst challenging, the agency costs are anticipated to reduce with on-going recruitment processes. This is dependent on the	
	bcess and timelines associated but other costs were expected to increase.
 Recovery Plans Women's and Children – In-Year savings and deliverables were 	
discussed and excellent progress has been made in the reduction of agency costs.	
Members believed urgent service re-configuration is required due to the number of	
expected vacancies in November 2023, which will be progressed.	
• Alignment of Nursing Act staffing requirements – a group will be reviewing all ward	
establishments (site by site) to ensure the Spring Nursing Act calculations are in place	
and built into rosters. At this point all additional duties will be removed to ensure grip and	
control is in place over rosters. It is also believed in some areas this will reduce agency	
as service lead	ds were confident around external recruitment into vacancies.

however looking at individual roles out of context is difficult to then decline or hold	

vacancies.
