The following items were discussed at the Finance Touchpoint Meeting held on 22nd March 2022:

Independent Member Pre-Meet Discussions

Mr Winston Weir confirmed the following items were discussed:

- Improving linkages between Strategic Development & Operational Delivery Committee (SDODC) and Sustainable Resource Committee (SRC) to provide assurance and insight to Board - Mr Weir to raise at the next Committee Chairs meeting;
- Strategic approach towards finances and savings and looking ahead at County level in 2-3 years;
- How to invite colleagues to the Committee for assurance purposes;
- Frequency of SRC meetings and work undertaken between meetings Mr Huw Thomas
 considers delivery to be the biggest challenge and Mr Michael Hearty stressed the important
 role the SRC plays in assisting the Director of Finance on delivery;
- Connecting with NHS Wales Shared Services Partnership (NWSSP) and receiving/assessing
 value for money Mr Thomas suggested raising this at the next Committee Chairs meeting
 for all joint services.

Review of January 2022 Touchpoint Notes and Actions

Finance Report / Finance Board Papers

Mr Thomas circulated the report submitted to Board. the Health Board has requested £4.5m funding from Welsh Government; £2m for core recovery; £2m for scanning and £0.5m British Red Cross coverage. The Electronic Staff Record (ESR), the roll out of the new rostering system, savings position, and agency spend were discussed and Mr Weir undertook to raise these at the People, Organisational Development and Culture Committee (PODCC).

Update to Key Corporate Risks

Mr Thomas confirmed that a new risk is to be incorporated in relation to sustainability, which
encompasses inflationary pressures and supply chain availability. The Ukrainian refugee
response was also discussed, which is being led by the Local Authority (LA). Mr Thomas
confirmed that capital resource and maintenance still remain a risk.

Update on Welsh Government Allocation

 Mr Thomas undertook to circulate a presentation on Micro-economics of Poverty given by Ms Rebecca Taylor from Public Health Wales. Mr Thomas voiced his concern regarding fuel costs and the impact on Health Board staff to commute and perform peripatetic roles. Mr Weir suggested this could be an item for Committee Chairs.

Progress on Medium Term Financial Plan

Covered in Board Seminar, no current update.

<u>Health Care Healthcare Contracting, Commissioning and Outsourcing Update</u> Discussed. Mr Maynard Davies suggested the submission of a report to SRC regarding A Regional Collaboration to Health (ARCH).
