Executive Summary

The following information tables were extracted from data held on the Electronic Staffing Records ((ESR B.I. Reporting Database) and i-View (reporting tool) for the period of 31st March 2017. In order to assess the percentages reported during this period the HDUHB comparator percentages for the period of 31st March 2016 were also used.

When undertaking the comparisons it should also be noted that due to the change in Headcount between both periods will show an impact on the statistics of the protected characteristics. This resulted in the Headcount as at the 31st March 2017 as being 11,003 and as at the 31st March 2016 as being 10,263 and thus an increase in the Headcount of 740.

It should be also be noted that the advocacy and use of ESR Self Service by Employees for those that have access to it, who have not already completed these areas, have the opportunity to do so using the Self Service function, which would aid in the collection of more accurate information.

Disability

Analysis Narrative

- Compared to 31st March 2016 the percentage of staff identifying as Not Disabled has increased by 7.75% by 31st March 2016.
- The percentage of staff identifying as having a Disability has increased in the reporting period by 0.16%.
- The percentage of staff choosing not to disclose this information (Not Disclosed) has risen by 0.67%.
- Unknown has fallen by 8.58%.

Sexual Orientation Analysis Narrative

 Compared to the 31st March 2016, the percentage of staff identifying as Bisexual has increased by 0.10%, The percentage of staff identifying as Gay has increased by 0.11% and the percentage of staff identifying as Lesbian has also increased by 0.05% as at 31st March 2017.

- The percentage of staff identifying as Heterosexual has increased by 5.49% for the reporting period.
- The percentage of staff choosing not to disclose this information has increased by 1.60%.
- Unknown has fallen by 7.32%.

Gender

Analysis Narrative

- Compared to the 31st March 2016 the percentage of employees identifying as has risen by 0.09% by 31st March 2017.
- The percentage of staff identifying as Female has decreased by 0.09% for the reporting period.

Religious Beliefs Analysis Narrative

- Compared to 31st March 2016 the percentage of staff identifying as having a religion or belief has risen by 3.89% as at 31st March 2017.
- The percentage of staff identifying as having Other Religious Belief also rose by 0.86% for the reporting period.
- The percentage of staff choosing not to disclose this information has risen by 2.58%.
- Unknown has fallen by 7.34%.

Marital Status

Analysis Narrative

- Compared to 31st March 2016 the percentage of staff detailing marital status information has risen by 0.08% by 31st March 2017.
- Unspecified has fallen by 0.72% for the period.

Age Profile

Analysis Narrative

- Compared to 31st March 2016 the percentage of staff identifying within the Age Profile for the ages of 54 and below has fallen by 0.33% by 31st March 2017.
- Age Profiles for the ages of 55 and above have shown a percentage increase of 0.33% for the period.

Maternity & Adoption Analysis Narrative

• Compared to 31st March 2016 the percentage of employees on leave due to Maternity and Adoption increased by 0.14% as against the percentage reported at 31st March 2017.

Ethnicity

Analysis Narrative

- Compared to 31st March 2016 the percentage of staff identifying as White has risen by 1.83% by 31st March 2017.
- The percentage of staff identifying as Black or Black British has risen by 0.06% for the reporting period.
- The percentage of staff identifying as Asian or Asian British rates decreased by 0.02%.
- The percentage of staff identifying as having Mixed ethnicity has increased by 0.06% for the same period.
- The percentage of staff identifying as from Any Other Ethnic Group has remained the same.
- Unknown has fallen by 1.93%.

Equalities Duties Reporting – Employment Relations Cases

EXECUTIVE SUMMARY

The following information tables were extracted from data held on ESR for the period 1 April 2016 to 31 March 2017. Some additional information was retrieved from local workforce case records, as not all the necessary information is available on ESR. The data for the period 1 April 2015 to 31 March 2016 has been used as a comparator as has the data on staff in post within the Health Board at 31 March 2017.

It should be noted that the overall numbers of cases of disciplinary and staff involved in grievances remain very small and the overall percentages reflect very small numbers. Also, in comparison with the preceding year's cases there is an overall decrease in the numbers of both grievance and disciplinary proceedings. This decrease actually amounts to 70 fewer disciplinaries and a further 69 fewer staff involved in grievances, which is a significant decrease compared to reports from previous years.

DISABILITY

GRIEVANCES

- Figures closely resemble the Health Board profile.
- The number of undefined staff has decreased by 53 when compared to the previous year.
- Disabled staff make up 2% of all cases.

- The numbers of those with a disability have decreased from 3 to 2, however only a small proportion of those subject to disciplinary proceedings (2%) consider themselves to have a disability.
- The number of not declared has increased to 4% compared to less than 1% the previous year.

GENDER

GRIEVANCES

- The number of females involved in grievances has decreased by 17%.
- The number of males involved in grievances has increased by 17% to represent 34% of all cases. This is disproportionate as males make up only 21.92% of the workforce.

DISCIPLINARY

- The number of females involved in the disciplinary process has declined by 5% compared to the previous year.
- Male involvement has increased by 5% to make up 30% of all cases.
- More females than males go through disciplinary proceedings, which is in line with the Health Board profile.

SEXUAL ORIENTATION

GRIEVANCES

- Heterosexuals make up 53% of all cases, an 11% increase compared to the previous year.
- The number of employees not wishing to disclose their sexual orientation has halved from 6% to 3%.
- No employees involved in grievances identify as lesbian or gay.

DISCIPLINARY

- Heterosexuals make up 61% of all cases. This has increased by 4% when compared to the previous year.
- The number of gay people that go through disciplinary proceedings has increased by 100% (2 cases).

The number of people who do not wish to disclose their sexual orientation has stayed the same at 7%.

RELIGIOUS BELIEFS

GRIEVANCES

- The number identified as Christians has marginally decreased to 30% compared to the previous year.
- Those under the category of 'other' have increased to 8% (5 cases).
- The numbers of employees who are undefined make up 42% of all cases.

DISCIPLINARY

- Christians remain by far the largest group of those with an identified religion at 61%.
- Although the number of atheists has dropped compared to last year, this category still makes up 8% of all disciplinary cases which is in line with the Health Board profile.
- Buddhists have again increased by 100% (from 1 to 2 cases) when compared to the previous year.
- Muslims make up 1% of all cases.
- Hinduism and Sikhism have both decreased by 100% and were nto involved in any disciplinary cases.

MARITAL STATUS

GRIEVANCES

- Single staff involved in grievances have decreased by 5% to 14%.
- The numbers of married staff involved in a grievance have increased to 67% of all cases. This is higher than the Health Board profile of 53%.
- The number of unknowns has increased from 4.5% to 9%.
- Cases where widow(er)s are involved in a grievance have remained the same (1 case).

- The numbers of married staff and civil partnerships involved in disciplinary proceedings have both decreased. There are still a very small number of staff within the civil partnership group (1 case).
- The number of unknowns has more than halved to 3%.
- Cases where staff fall within the widowed category have increased by 50% (2 to 3 cases).

MATERNITY & ADOPTION

GRIEVANCES & DISCIPLINARY

 There are no employees with this characteristic going through grievance or disciplinary proceedings.

ETHNICITY

GRIEVANCES

- White ethnicity makes up 77% of all grievance cases. This is lower than the Health Board profile which is 82%.
- The other 23% of grievances (14 cases) are made up of unknown ethnicity and another ethnic group not previously stated (1 case).
- The number of employees with unknown ethnicity has increased slightly by 1%.

DISCIPLINARY

- White ethnicity makes up 86% of those subject to disciplinary proceedings. This is slightly over the Health Board profile of 82%.
- The number of employees with unknown ethnicity has decreased by 3% to 9%.

AGE

GRIEVANCE

- The number of 60+ reporting grievances has decreased to 2% from 5% the previous year.
- Similar to the previous year, most grievances are within the 50-54 age bracket; totaling 28% of all cases and a 3% decrease.
- Most notably, those under 35 make up 8% of all cases this year. This is a significant decrease when compared to the previous year, where 18% of employees from this age bracket were involved in grievances.

- The age profiles of staff subject to disciplinary investigations are broadly in line with the Health Board's profile.
- The number of staff aged 50-54 has also reduced by 3%, yet still holds the biggest age bracket of staff going through disciplinary proceedings.

SUMMARY OF KEY POINTS

GRIEVANCES

- Overall there has been a significant reduction in the number of grievance cases raised when compared to the previous year. This can be explained in part by a reduction in collective grievances lodged.
- When compared to the number of staff employed by the Health Board, overall the number of grievance cases actually only equates to 0.58% of all staff.

- There has been a significant reduction in the number of disciplinary cases during this period (April 2016 to March 2017).
- When compared to the number of staff employed by the Health Board, overall the number of disciplinary cases actually only equates to 0.85% of all staff.
