#### **Equalities Duties Reporting – Staff in Post**

#### **Executive Summary**

The following information tables were extracted from data held on the Electronic Staffing Records ((ESR B.I. Reporting Database) and i-View (reporting tool) for the period of 31<sup>st</sup> March 2018. In order to assess the percentages reported during this period the HDUHB comparator percentages for the period of 31<sup>st</sup> March 2017 were also used.

When undertaking the comparisons it should also be noted that due to the change in Headcount between both periods will show an impact on the statistics of the protected characteristics. This resulted in the Headcount as at the 31<sup>st</sup> March 2018 as being 10,844 and as at the 31<sup>st</sup> March 2017 as being 11,003 and thus a decrease in the Headcount of 159.

It should be noted that the reason for the decrease is due to this year's review having data cleansed the ESR reporting database to take out any inactive - not worked assignments and this resulted in the decrease.

It should be also be noted that the advocacy and use of ESR Self Service by Employees for those that have access to it, who have not already completed these areas, have the opportunity to do so using the Self Service function, which would aid in the collection of more accurate information.

#### Disability

## **Analysis Narrative**

- Compared to 31<sup>st</sup> March 2017 the percentage of staff identifying as Not Disabled has increased by 5.44% by 31<sup>st</sup> March 2018.
- The percentage of staff identifying as having a Disability has increased in the reporting period by 0.25%.
- The percentage of staff choosing not to disclose this information (Not Disclosed) has risen by 0.19%.
- Unknown has fallen by 5.88%.

## **Sexual Orientation Analysis Narrative**

 Compared to the 31<sup>st</sup> March 2017, the percentage of staff identifying as Bisexual has increased by 0.04%, The percentage of staff identifying as Gay has increased by 0.07% and the percentage of staff identifying as Lesbian has also increased by 0.03% as at 31<sup>st</sup> March 2018.

- The percentage of staff identifying as Heterosexual has increased by 2.42% for the reporting period.
- The percentage of staff choosing not to disclose this information has increased by 1.69%.
- Unknown has fallen by 4.25%.

#### **Analysis Narrative**

- Compared to the 31<sup>st</sup> March 2017 the percentage of employees identifying as Male has fallen by 0.13% by 31<sup>st</sup> March 2018.
- The percentage of staff identifying as Female has increased by 0.13% for the reporting period.

#### Religious Beliefs Analysis Narrative

- Compared to 31<sup>st</sup> March 2017 the percentage of staff identifying as having a religion or belief has risen by 2.26% as at 31<sup>st</sup> March 2018.
- The percentage of staff identifying as having Other Religious Belief also rose by 0.16% for the reporting period.
- The percentage of staff choosing not to disclose this information has risen by 1.83%%.
- Unknown has fallen by 4.26%.

#### **Analysis Narrative**

- Compared to 31<sup>st</sup> March 2018 the percentage of staff detailing marital status information has risen by 0.49% by 31<sup>st</sup> March 2018.
- Unspecified has fallen by 0.49% for the period.

#### **Analysis Narrative**

- Compared to 31<sup>st</sup> March 2017 the percentage of staff identifying within the Age Profile for the ages of 54 and below has risen by 2.03% at 31<sup>st</sup> March 2018.
- Age Profiles for the ages of 55 and above have shown a percentage decrease of 2.03% for the period.

### Maternity & Adoption Analysis Narrative

• Compared to 31<sup>st</sup> March 2017 the percentage of employees on leave due to Maternity and Adoption decreased by 0.29% as against the percentage reported at 31<sup>st</sup> March 2018.

#### **Analysis Narrative**

- Compared to 31<sup>st</sup> March 2017 the percentage of staff identifying as White has risen by 0.52% by 31<sup>st</sup> March 2018.

#### **EXECUTIVE SUMMARY**

The following information was extracted from data held on ESR for the period 1 April 2017 to 31 March 2018. Some additional information was retrieved from local workforce case records, as not all the necessary information is available on ESR. The data for the period 1 April 2016 to 31 March 2017 has been used as a comparator as has the data on staff in post within the Health Board at 31 March 2018.

It should be noted that overall, numbers of cases of disciplinary and staff involved in grievances remain very small and the overall percentages reflect very small numbers. Also, in comparison with the previous year's cases there is again an overall decrease in the numbers of both grievance and disciplinary proceedings. This decrease actually amounts to 10 fewer disciplinaries and a further 32 fewer staff involved in grievances, which is a significant decrease compared to reports from previous years.

#### DISABILITY

#### **GRIEVANCES**

- Figures are slightly higher than the Health Board profile.
- The number of staff who have chosen not to declare this information has increased to 2 people when compared to the year before.
- Disabled staff make up 3% of all cases.

#### DISCIPLINARY

- The numbers of those with a disability who are subject to disciplinary proceedings has decreased from 2 to 1 case.
- This equates to 1% of all disciplinary proceedings and is in line with the Health Board profile.

#### **GENDER**

#### **GRIEVANCES**

- The number of females involved in grievances has decreased by 7%.
- The number of males involved in grievances has increased by 7% to represent 41% of all cases. This is disproportionate in relation to the Health Board profile as males make up only 21.79% of the workforce.

- The number of females involved in the disciplinary process has increased by 2% when compared to the previous year.
- Male involvement makes up 28% of all disciplinary cases.

• Figures are broadly in line with the Health Board profile where 78.21% identify as female and 21.79% identify as male.

#### **SEXUAL ORIENTATION**

#### **GRIEVANCES**

- Heterosexuals make up 53% of all cases. This has not changed when compared to the previous year.
- The number of employees not wishing to disclose their sexual orientation has increased from 3% to 9%.
- No employees involved in grievances identify as lesbian, gay or bisexual.

#### DISCIPLINARY

- Heterosexuals make up 63% of all cases. This has increased by 2% when compared to the previous year.
- The number of gay people that go through disciplinary proceedings has decreased by 50% compared to the previous year (1 case).
- The number of people who do not wish to disclose their sexual orientation has decreased from 7% last year to 2% this year.

#### **RELIGIOUS BELIEFS**

#### **GRIEVANCES**

- The numbers of those identifying as Christian has marginally decreased from 30% last year to 28% this year. This is lower than Health Board profile of 37.34%.
- Those under the category of 'other' have increased to 15% (5 cases).
- The numbers of employees who have not defined their religious belief make up 38% of all cases.
- Atheists make up 6% of all grievance cases.

- Christians remain by far the largest group of those with an identified religion who are subject to disciplinary proceedings at 39%.
- Although the number of atheists has dropped compared to last year, this category still makes up 6% of all disciplinary cases which is slightly lower than the Health Board profile.
- Buddhists make up 2% of all cases (2 cases).
- Those identifying their religion as Islam, Hinduism and Judaism were not involved in any disciplinary cases.

#### **MARITAL STATUS**

#### **GRIEVANCES**

- The number of single staff involved in grievances has doubled from 14% last year to 28% which is just below the Health Board profile of 30.75%.
- The number of married staff involved in grievances has increased to 41% of all cases. This is lower than the Health Board profile of 53.54%.
- The number of divorced staff involved in grievances is 13%, which is higher than the Health Board profile of 7.03%.

#### **DISCIPLINARY**

- The number of married staff involved in disciplinary proceedings has decreased slightly to 36%.
- Cases where staff fall within the widowed category have decreased from 3 to 2 cases.

#### **MATERNITY & ADOPTION**

#### **GRIEVANCES & DISCIPLINARY**

 There are no employees with this characteristic going through grievance or disciplinary proceedings.

#### **ETHNICITY**

#### **GRIEVANCES**

- White ethnicity makes up 84% of all grievance cases. This is in line with the Health Board profile of 82.95%.
- The other 16% of grievances are made up of Black employees, Asian employees and those who have not stated their ethnicity.

- White ethnicity makes up 82% of those subject to disciplinary proceedings. This is slightly under the Health Board profile of 82.95%.
- There are a small number of cases in which employees are of Asian ethnicity.

#### AGE

#### **GRIEVANCE**

- The number of 60+ reporting grievances has increased to13% from 5% the previous vear.
- Most grievances are within the 50-54 and 55-59 age brackets; totaling 47% of all cases.
- Most notably, those aged 29 and under make up 18.45% of the workforce did not raise any grievances.

#### **DISCIPLINARY**

- Those employees aged under 25 account for 3% of all disciplinary cases, which is lower than the Health Board profile of 8.20%.
- The numbers of those involved in disciplinary proceedings are mainly distributed between those aged 25-29 (11 cases) and 40-59 (51 cases).

#### SUMMARY OF KEY POINTS

#### **GRIEVANCES**

- Overall there has been a significant reduction of 50% in the number of grievance cases raised when compared to the previous year. This can be explained in part by a reduction in collective grievances lodged and resolution of informal grievances at an early stage.
- When compared to the number of staff employed by the Health Board, overall the number of grievance cases only equates to 0.30% of all staff.

- There has been a reduction in the number of disciplinary cases from 93 cases to 83 cases during this period (April 2017 to March 2018).
- When compared to the number of staff employed by the Health Board, overall the number of disciplinary cases only equates to 0.77% of all staff.
