As you know from our conversations, discussions have been taking place between Directors of Public Health, Public Health Wales and the Welsh Government about the proposed transfer of Local Public Health Teams from Public Health Wales to Health Boards.

Following these conversations, I now enclose a letter from Andrew Goodall, Director General Health and Social Services/NHS Wales Chief Executive, supporting the proposed transfer.

We will be writing to staff tomorrow, 21 October 2021, to update them on this proposed change and we will be working closely with your teams to enable this change to take place through a structured programme. Our aim is to work together with Directors of Public Health for a seamless and supportive transfer of staff from the 1 April 2022.
