Response:

- Hywel Dda University Health Board's (UHB) bereavement services are operated on an individual site basis. The UHB currently has a temporary bereavement nurse in situ who provides a point of contact for general and organisation wide matters.
- 2. The UHB is withholding the contact details of the members of staff requested. This decision has been made as it is not within the expectations of these individuals that their personal data would be put into the public domain. This information is classed as personal data of third parties and is therefore being withheld in accordance with section 40(2) of the Freedom of Information Act 2000 by virtue of section 40(3) (a) (i) of the Act which permits a public authority to withhold personal data other than the requester's where the disclosure would breach a Data Protection Principle.

In reaching this decision, the Data Protection Act 2018/General Data Protection Regulations 2016 defines personal data as data which relates to a living individual who can be identified solely from that data or from that data and other information, which is in the possession of the data controller.

The UHB can provide the email address for patient support services, who can be contacted for advice HDHB.Patientsupportservices@wales.nhs.uk and will be able to forward any enquiries onto the relevant contact.

- 3. The UHB confirms, a bereavement booklet is provided to the family of any patient who dies in hospital.
- 4. The UHB confirms, no one person deals with the bereavement booklets. The bereavement office, mortuary staff or ward staff have access to and can provide the booklet.
- 5. The UHB confirms the bereavement booklets are produced by an external company.
- 6. The UHB confirms some guides are produced internally. However, the general guides are produced externally.
- 7. The UHB confirms it does not have a contract with an external agency for the production of bereavement booklets and guides.
