- 12. Does the service run symptomatic clinics on a 5 day or 7 day week?
- 13. Who has the overall responsibility for the symptomatic breast clinics?

<u>Breast Screening – (Asymptomatic)</u>

Symptomatic Mammography & Breast Clinics

- 7. The UHB confirms symptomatic breast clinics are provided at Bronglais General Hospital (BGH), Prince Philip Hospital (PPH) and Withybush General Hospital (WGH).
- 8. The UHB confirms the symptomatic breast clinics are run separately to breast screening clinics, which are independently provided by BTW.
- 9. The UHB confirms symptomatic breast clinics are provided at BGH, PPH and WGH.
- 10. The UHB's outpatient departments at the three (3) hospitals mentioned above have the responsibility for symptomatic mammograms and symptomatic breast lists/clinics.
- 11. Within the table below, the UHB provides the average number of assessments per day:

Hospital	Average assessments per day
Bronglais General Hospital (BGH)	5
Prince Philip Hospital (PPH)	9
Withybush General Hospital (WGH)	5

- 12. The UHB provides symptomatic clinics five (5) days per week.
- 13. The overall responsibility for the symptomatic breast clinics in the UHB lies with the cancer services consultants.
- 14. This information is already within the public domain therefore the UHB has applied an Exemption under Section 21 of the Freedom of Information Act 2000, as the information is accessible by another means. The UHB's organisational charts are available on the NHS Wales website.
