7. Clinical guidance must be sought from the Agenda for Change (AfC) Band 8 Clinical Lead, who will then authorise the issue of any pressure care equipment.

Individual assessment of the patient's risk of developing pressure damage, and their home environment, will determine use of specialist pressure relieving equipment. For patients assessed as being at risk of developing pressure damage, use of a high specification pressure redistributing foam mattress should be recommended.

However, consideration must be given to the extended time period between nursing visits and the patient's home circumstances. Where patients may not have regular assistance available to help them change their position, additional equipment such as a medium and high risk dynamic mattress may also be required to decrease the risk of developing pressure damage.
