1. & 2. Care home data is not the responsibility of Hywel Dda University Health Board (UHB).

- 3a. The UHB confirms two hundred and twenty-one (221) patients are recorded as being discharged from UHB hospitals to care homes for the period 1 March to 15 April 2020.
- 3b. The UHB confirms one hundred and forty-nine (149) patients are recorded as being discharged from UHB hospitals to care homes for the period 16 April to 16 June 2020.
- 4a. The UHB confirms thirty (30) of the patients discharged were tested for COVID-19 for the period 1 March to 15 April 2020.
- 4b. The UHB confirms one hundred and twenty-six (126) of the patients discharged were tested for COVID-19 for the period 16 April to 16 June 2020.
- 5. The UHB provides, within the table below, the number of patients that produced positive, negative and inconclusive results for COVID-19, for the period March to 16 June 2020.

6. The UHB is unable to provide you with the information requested, as it is estimated that the cost of answering your request would exceed the "appropriate level" as stated in the Freedom of Information (Fees and Appropriate Limit) Regulations 2004. The "appropriate level" represents the estimated cost of one person spending 18 hours or (2 ½ working days) in determining whether the UHB holds the information, and locating, retrieving and extracting the information.

In order to provide you with this information, the UHB would need to undertake a manual trawl of discharged patient records who tested positive for COVID-19 to identify any information that would fulfil your request. The number of patients discharged that tested positive was 148; therefore, conducting the search would far exceed the 'appropriate level', costing the UHB the following:

148 @ 15 minutes per patient record = 37 hours 37 hours @ £25 per hours = £925.00

Therefore, the UHB is applying an exemption under Section 12 of the Freedom of Information Act 2000, which provides an exemption from a public authority's obligation to comply with a request for information, where the cost of compliance is estimated to exceed the appropriate limit.

The UHB provides, within the table below, the number of care home residents admitted to hospital from care homes, broken down into those who were suspected/confirmed as having COVID-19 and the non COVID-19 related admissions for the period 27 February and 16 June 2020. The date range has been extended to provide the numbers for full weeks.
