The UHB is therefore withholding this detail under Section 40(2) of the Freedom of Information Act 2000. This information is protected by the Data Protection Act 2018/ General Data Protection Regulations 2016 (GDPR), as its disclosure would constitute unfair and unlawful processing and would be contrary to the principles and articles 6 and 9 of the GDPR. - 3c. The UHB does not hold this information.
- 4. The GP Cluster Youth Project commenced in October 2020; therefore, the UHB does not hold the information requested. However, the UHB can provide, within the table below, the number of children and young people that accessed the EHWS, for the financial years requested.
