The UHB has applied a section 40(2) exemption and is therefore, withholding the name of the member of staff. A full exemption explanation is set out in the response to question 8a.
- 4. Anthony Tracey, Assistant Director of Digital Services is the UHB's lead for digital strategy.
- 5. The UHB confirms that the job title for the strategic performance lead is Head of Strategic Performance. The UHB has applied a section 40(2) exemption and is therefore, withholding the name of the member of staff. Again, a full exemption explanation is provided in the response to question 8a.
- 6. The UHB's lead for transformation is Lee Davies, Executive Director of Strategic Development and Operational Planning.
- 7. The UHB's Chief Information/Technology Officer is provided in the response to question 4.
- 8. The UHB confirms that it does have a team that is responsible for digital innovation.
 - a. The team responsible for digital innovation is the Digital Improvement and Transformation (DI&T) Team.

The UHB is withholding the names of the members of staff requested. This decision has been made as it is not within the expectations of these individuals that their personal data would be put into the public domain. This information is classed as personal data of third parties and is therefore being withheld in accordance with section 40(2) of the Freedom of Information Act 2000 (FoIA) by virtue of section 40(3) (a) (i) of the Act, which permits a public authority to withhold personal data other than the requester's where the disclosure would breach a Data Protection Principle.

In reaching this decision, the Data Protection Act 2018/General Data Protection Regulations 2016 defines personal data as data which relates to a living individual who can be identified solely from that data or from that data and other information, which is in the possession of the data controller.

- 9. The UHB confirms that its DI&T Team does not develop front facing service user websites or applications.
- 10. The UHB confirms that its DI&T Team has not applied for external tenders for healthcare developments.
- 11. The UHB confirms that its DI&T Team has not undertaken developments for other organisations or external entities.
- 12. The UHB confirms that its DI&T Team has not sold a development it has produced commercially.
- 13. The UHB confirms that its DI&T Team has not attempted to secure an innovation grant.
