Please note: The majority of the above were recruited from individual applications made via NHS jobs, or occasionally via recruiting agencies, that have been asked to recruit to individual vacancies for exceptionally hard to fill posts.

Where the figures in the table have been replaced with an asterisk (*), the UHB is unable to provide you with the exact numbers and is unable to provide the data broken down in to the three (3) staff groups requested, due to the low numbers of cases (5 and under), as there is a potential risk of identifying individuals if this was disclosed. The UHB is therefore withholding this detail under Section 40(2) of the FoIA. This information is protected by the Data Protection Act 2018/General Data Protection Regulations 2016 (GDPR), as its disclosure would constitute unfair and unlawful processing and would be contrary to the principles and articles 6 and 9 of the GDPR. This exemption is absolute and therefore, there is no requirement to apply the public interest test.

In reaching this decision, the Data Protection Act 2018/General Data Protection Regulations 2016 defines personal data as data which relates to a living individual who can be identified solely from that data or from that data and other information which is in the possession of the data controller.

4. The UHB confirms that fourteen (14) doctors have been recruited from countries graded 'red' on the WHO list during the period 1 January 2021 to 31 July 2021;12 have started in post and two are waiting for a commencement date.

No other healthcare professionals have been recruited from countries graded 'red' on the 'WHO' list during the period January 2021 to 31 July 2021.

All offers of employment have been made following individual applications in response to adverts for individual posts on-line following an advert on NHS Jobs or with agencies for the purpose of securing permanent doctors from overseas who comply with the standards supporting ethical recruitment. The UHB has not initiated international recruitment campaigns. However, have responded to expressions of interest for individual vacancies from individual candidates.

- a. The UHB confirms that the third-party recruitment agencies used to support the passage of the professionals to the UK from offer stage onward are Medacs and BDI Resourcing. However, the UHB's Medical Recruitment Team manage the on-boarding process with the Recruitment Agencies only being utilised in the identification of suitable candidates.
