How many members of public are tested at these facilities (either per day, per week or per month).
2. How many Community Testing Units (CTUs) providing Covid-19 testing service are available through your Health Board and who physically provide this service (full details of contractor, contract start and duration including the cost of the contract and future (planned) contracts). How many members of public are tested at these facilities (either per day, per week or per month).
3. How many Mobile Testing Unit (MTU) providing Covid-19 testing service are available through your Health Board and who physically provide this service (full details of contractor, contract start and duration including the cost of the contract and future (planned) contracts). How many members of public are tested at these facilities (either per day, per week or per month).
4. How many Local Test Sites (LTS) providing Covid-19 testing service are available through your Health Board and who physically provide this service (full details of contractor, contract start and duration including the cost of the contract and future (planned) contracts). How many members of public are tested at these facilities (either per day, per week or per month).

**Response:**

1. Hywel Dda University Health Board (UHB) confirms that it has one (1) Mass Testing Centre, located in Carmarthen which provides drive-through COVID-19 testing and has the capacity to deliver five hundred (500) swabs per day. This is delivered and managed by Sodexo. The UHB does not hold the Sodexo contract details, as it is managed by the Department of Health and Social Care (DHSC). For clarity, both the MTC and CTU based in Carmarthen are hosted at the same location.

The UHB confirms that it has access to five (5) Mobile Testing Units, for use across the UHB's geographical area, with a capacity to deliver two thousand five hundred (2,500) swabs per day, provided by Sodexo. The UHB does not hold the Sodexo contract details as it is managed by DHSC.
