The UHB confirms that the MAS clinics are currently staffed with a Consultant Neuropsychologist in their role as Clinical Lead for the service with each Memory Assessment Team (MAT) having approximately three (3) Whole Time Equivalent (WTE) Band 6 Registered Mental Health Nurses (RMN) and one Band 8a Advanced Nurse Practitioner (ANP, non-medical Prescriber).

In addition, Occupational Therapy (OT), Advanced Practice Pharmacist (Independent Prescriber), Psychology, Health Care Support Worker (HCSW) and Consultant Psychiatrist input is available, when required, from the Older Adult Community Mental Health Teams (OAMHT).

- 5. The UHB confirms that Liz Carroll, Executive Director for Mental Health and Learning Disabilities, has overall responsibility for the MAS'.
- 6. The UHB confirms that there is no provision for Amyloid-PET imaging (API) or Cerebrospinal Fluid Testing (CSF) within the MAS.
