## Response:

Hywel Dda University Health Board (UHB) is unable to provide you with all of the information requested, as it is estimated that the cost of answering your request would exceed the "appropriate level" as stated in the Freedom of Information (Fees and Appropriate Limit) Regulations 2004. The "appropriate level" represents the estimated cost of one person spending 18 hours (or 2 ½ working days) in determining whether the UHB holds the information, and locating, retrieving and extracting the information.

Some of the information being requested is not held centrally, and so in order to provide you with the historical data requested for questions 2, 3 and 4, the UHB would need to undertake a review of notes from the Eligibility and Quality Assurance Panel meetings to identify the patients that meet the criteria for continuing healthcare and then cross reference with individual patient files to determine the actual numbers, for each of the two (2) financial years requested.

The UHB is therefore applying an exemption under Section 12 of the Freedom of Information Act 2000 (FoIA), which provides an exemption from a public authority's obligation to comply with a request for information where the cost of compliance is estimated to exceed the appropriate limit.

However, under section 16 of the FoIA, we are required, as a public authority, to provide advice and assistance so far as it is reasonable, to individuals who have made a request under FoIA and therefore the UHB provides the accessible information below.

1. Hywel Dda University Health Board (UHB) provides, within the table below, the number of individuals that were granted NHS CHC funding via the Fast-Track Pathway, during the financial years 2018/19, 2019/20 and 2020/21.
