Response:

- 1. The Whole Time Equivalent (WTE) number of Occupational Therapists (OT's), Occupational Therapist Manager or Occupational Therapist Specialist Practitioner employed by Hywel Dda University Health Board (UHB) as at 31 August 2022 was 150.05.
- The WTE number of Occupational Therapists (OT), Occupational Therapist Manager or Occupational Therapist Specialist Practitioner employed by the Health Board as at 31st August 2017 was 124.45.
- 3. The UHB employs six (6), equating to 5.8 WTE Health and Care Professions Council (HCPC) registered OT's in positions that don't have Occupational therapy in the title.
- 4. The UHB is unable to provide the number of unregistered staff that support occupational therapy services, as our electronic staff record does not provide information on staff outside of the OT service that are specifically supporting OT services.

However, the Health Board has provided the WTE number of support staff working within the OT service as at 31 August 2022 within the table below.
