Requested:

 - b. What training (if any) is provided to members of this team?
 - c. Please provide the annual salary for each member of the team for each year from 2020 to 2022 inclusive.
 - d. Please provide details of any additional budget allocated to the team, i.e. for operational costs, equipment, office space etc. for each year from 2020 2022 inclusive.
 - e. Has the overseas visitor team overspent its budget in any year from 2020 2022 inclusive? If yes, provide the amount.
 - f. If the health board does not employ an overseas visitor manager does it plan to, and if so, how much has it budgeted for this?
