<u>Response</u>:

Hywel Dda University Health Board (UHB) is unable to provide you with the information requested for question 3a, as it is estimated that the cost of answering your request would exceed the "appropriate limit" as stated in the Freedom of Information Act 2000 and the Data Protection (Appropriate Limit and Fees) Regulations 2004. The "appropriate limit" represents the estimated cost of one person spending 18 hours (or 2½ working days) in determining whether the UHB holds the information, and locating, retrieving and extracting the information.

In order to provide you with the minutes requested, the UHB would be required to undertake a manual search of systems. This is due to the meeting being a collaboration of departments including Medicines Management, Primary Care and Operational Teams, with some staff members that attended the meeting having terminated their employment with the UHB and the minutes may have been stored on their individual PCs. Hence, the need for a system trawl to locate and identify any information that would fulfil this part of your request.

The UHB is therefore applying an exemption under Section 12 of the Freedom of Information Act 2000 (FoIA), which provides an exemption from a public authority's obligation to comply with a request for information where the cost of compliance is estimated to exceed the appropriate limit.

However, under section 16 of the FoIA, the UHB has a duty to provide advice and assistance. Therefore, the UHB provides the accessible information it holds below.

The Medicines Formulary and Guidance Group (MFGG) recommended the Cobweb Formulary for Continence Products, which was approved by the Medicines Management Subcommittee.
