Decision

Following a review of your correspondence, Hywel Dda University Health Board (UHB) has made the decision to refuse some of your requests for information on the basis that the requests will be of little benefit to the wider public. The UHB's reasons are provided in bullet point form below; the remainder of your requests will be answered at the end of this letter.

• The UHB has an obligation to respond to valid requests for information. A valid request for information can be determined using the guidance provided in Section 8 of the Freedom of

Information Act 2000 (FoIA). The UHB has drawn the conclusion that (some of) the requests are not valid requests for information and therefore not admissible under FoIA.

- The UHB considers (many of) the requests to be vexatious. Vexatious requests can be determined using the guidance as set out in Section 14 of the FoIA. The points drawn upon by the UHB to reach this decision are provided below:
 - Multiple requests with a similar or related subject matter have been submitted to multiple UHB officers within a short timeframe, the requestor sends in new overlapping requests before the UHB has had an opportunity to address their earlier enquiries.
 - The UHB recognises that (some of) the requests submitted are repetitive and have previously been answered in full by the UHB.
 - The requestor is attempting to reopen an issue which has already been comprehensively addressed by the UHB, or otherwise subjected to some form of independent scrutiny.
 - The UHB believes that the requests are part of a scattergun approach, which lacks any clear focus and are intended to waste time and/or unnecessarily utilise resources for no apparent purpose.
 - A number of the requests are simply trivial or frivolous and require disproportionate effort from UHB officers to handle.
 - The requestor is abusing their rights of access to information by using the legislation to harass and annoy the UHB, for example, by requesting information which the UHB knows them to possess already.


1. The UHB confirms that Primary Care is currently in the process of a two (2) year programme for the implementation of call recording. Therefore, not all GP Practices have this facility as yet, but they will be working towards its implementation.

The individual GP Practices will need to be contacted directly to comment on whether or not this facility is available yet. Please note that there are a number of systems available, with each practice being responsible for purchasing and maintaining their own systems.

FOI 8353

1. The UHB is withholding the full name of the member of staff requested for question 1, as the UHB has no legitimate reason for processing their data as they are no longer employed by the UHB. This information is classed as personal data of third parties. Therefore, the UHB is withholding this detail under Section 40(2) of FoIA, by virtue of section 40(3) (a) (i) of the FoIA which permits a public authority to withhold personal data other than the requestor's where the disclosure would breach a Data Protection Principle.

This information is protected by the Data Protection Act 2018/General Data Protection Regulations 2016 (GDPR), as its disclosure would constitute unfair and unlawful processing and would be contrary to the principles and articles 6 and 9 of the GDPR. This exemption is absolute and therefore, there is no requirement to apply the public interest test.

In reaching this decision, the Data Protection Act 2018/General Data Protection Regulations 2016 define personal data as data which relates to a living individual who can be identified solely from that data or from that data and other information which is in the possession of the data controller.

a. The UHB confirms that all Medical professionals are required to have a GMC registration number to enable them to practise.

Information on GMC registration numbers is within the public domain and therefore, the UHB has applied an exemption under Section 21 of the FoIA, as the information is accessible by another means. This information is on the General Medical Council's (GMC) website.
