- 5. The UHB confirms that it does not have a specialist seating contract in place. All specialist seating is purchased/rented as and when needed.
- 6. The UHB confirms that there have been two (2) entries recorded on the UHB's risk register relating to specialist seating and both are still open, during the period 23 August 2022 to 22 August 2023.
- 7. The UHB has several Multidisciplinary Teams (MDTs) across all of its services to provide fundamental care for patients.

The UHB's Therapies service works collaboratively with other services to support individual patients. The team has a range of well defined MDTs that are specifically involved in managing patients requiring specialist seating as follows:-

- Paediatrics Three (3) MDTs, one (1) for each Geographical County: Carmarthenshire, Ceredigion and Pembrokeshire
- Learning Disabilities Three (3) MDTs, one (1) for each Geographical County: Carmarthenshire, Ceredigion and Pembrokeshire
- Community based Neurological rehabilitation MDTs Six (6):
 North and South Ceredigion, Pembrokeshire, Carmarthenshire 3Ts (Taf/Teifi/Tywi)
 Communites, Amman Gwendraeth and Llanelli
- Acute hospital Neurological/Stroke MDTs Four (4): Bronglais General Hospital, Glangwili General Hospital, Prince Philip Hospital and Withybush General Hospital
- Specialist Community Neurological team (advanced practitioners) one (1): Health Board wide remit.

Additionally, MDTs can be arranged at short notice to discuss an individual's needs, where required.
