Requested:

I am trying to get an all-Wales picture over the last few years and would be grateful if you could provide me with information for each of the last five years.

I would be grateful for the following information:

- 1. For each of the last five financial years, how much was spent on private taxi and ambulance journeys, and how many times were they used?
- 2. Which companies were used for this work?
- 3. What was the general reason for the journeys i.e. what percentage was patient transport, how much was staff use, transport medicine, courier, etc.?
- 4. How much was spent on transporting patients, how many times were they used, and what percentage of all patient transport was this?
- 5. Of the patient transport, how many were emergency calls, what percentage of all emergency calls were they and what was the financial cost?
- 6. Of the patient transport, how many were non-emergency calls, what percentage of all nonemergency patient transport were they, and what was the cost?
- 7. What was the highest and lowest charge for one journey?
