FOI.13608 – Waits over three (3) years

- 1. The number of patient pathways in your health board that are waiting over 3 years (157 weeks) for treatment.
- 2. The specialty for which these patients are waiting over 157 weeks for treatment.

FOI.13609 – Outpatient appointments and surgery cancellations

- 1. The number of operations that have been cancelled in your health board for each of the last 12 months (and a breakdown of reason for cancellation)
- 2. The average length of time between the date of the cancelled operation and the date the rescheduled operation
- 3. The number of cancer operations that have been cancelled in your health board for each of the last 12 months (and a breakdown of reason for cancellation)
- 4. The average length of time between the date of the cancelled cancer operation and the date the rescheduled operation
- 5. The number of cancelled outpatient appointments in your health board for each of the last 12 months (and a breakdown of reason for cancellation)
- 6. The average length of time between the date of the cancelled outpatient appointment and the date the rescheduled outpatient appointment
- 7. The number of outpatient appointments for suspected cancer in your health board for each of the last 12 months (and a breakdown of reason for cancellation)
- 8. The average length of time between the date of the cancelled suspected cancer outpatient appointment and the date the rescheduled suspected cancer outpatient appointment

Response:

Hywel Dda University Health Board (UHB) is unable to provide you with all of the information requested, as it is estimated that the cost of answering your request would exceed the "appropriate limit" as stated in the Freedom of Information Act 2000 and the Data Protection (Appropriate Limit and Fees) Regulations 2004. The "appropriate limit" represents the estimated cost of one person spending 18 hours (or 2½ working days) in determining whether the UHB holds the information, and locating, retrieving and extracting the information.

Due to the complexity and size of the request, the "appropriate limit" has been reached in the collation of the data. Therefore, the UHB is unable to provide the information for question 6 of FOI.13609 as it has exceeded the time/cost limit allowed under the FoIA.

The UHB is therefore applying an exemption under Section 12 of the Freedom of Information Act 2000 (FoIA), which provides an exemption from a public authority's obligation to comply with a request for information where the cost of compliance is estimated to exceed the appropriate limit.

However, under section 16 of the FoIA, the UHB has a duty to provide advice and assistance. Therefore, the UHB provides, the accessible information it holds for the remainder of your request below.

FOI.13608 – Waits over three (3) years

- 1. Hywel Dda University Health Board (UHB) confirms that there are six hundred and ninety six (696) patient pathways that have been waiting over three (3) years for treatment, as recorded on the UHB's Welsh Patient Administration System (WPAS), as at the date of your request.
- 2. The UHB provides overleaf, the specialty for which patients have been waiting over three (3) years for treatment, as recorded on the UHB's WPAS.

FOI.13609 – Outpatient appointments and surgery cancellations

For questions 1, 3 and 7, the UHB is unable to provide you with the information broken down by month as requested, due to the low number of cases (5 and under), as there is a potential risk of identifying individuals if this was disclosed. Additionally, for questions 1, 3, 5 and 7, where the figures in the tables have been replaced with an asterisk (*), the UHB is unable to provide you with the exact number of patients, again due to the low number of cases (less than 5). The UHB has also replaced totals which could be used to calculate the redacted figure with a double asterisk (**). Therefore, the UHB is withholding these details under Section 40(2) of the FoIA.

This information is protected by the Data Protection Act 2018 (DPA)/UK General Data Protection Regulations, as its disclosure would constitute unfair and unlawful processing and would be contrary to the principles and articles of the UK GDPR. This exemption is absolute and therefore, there is no requirement to apply the public interest test.

In reaching this decision, the DPA and UK GDPR define personal data as data that relates to a living individual who can be identified solely from that data or from that data and other information, which is in the possession of the data controller.

8. The UHB confirms that not all of the appointments have been rescheduled due to various reasons including patients are already on an open pathway, they have been seen elsewhere, discharged to a See on Symptom (SOS) or they were on the wrong pathway. However, of the

cancelled outpatient appointments for suspected cancer that have been re-scheduled, the average time was nineteen (19) days.
