- Concerns in relation to equitable access to tertiary services for HDdUHB patients;
- Concerns in relation to provision of suitable placements for patients with complex mental health conditions.

The Healthcare Professionals Forum raised the following key risks and issues/matters of concern:

- Primary Care members reported instances of patients returning to Primary Care, having been referred to Secondary Care, with the Forum querying the capacity required to address the backlogs created. The Forum was satisfied to hear that the COVID-19 outbreak had been a situation where all parties have had to learn and rethink many established systems and pathways which had resulted in instances of unintended circumstances occurring. Work is ongoing to identify and address the capacity and backlog.
- It was noted that patients' digital solutions had not always allowed for virtual consultations, meaning that this model does not suit all circumstances. The Forum was satisfied that this challenge was understood, and that alternative access would be necessary for these patients.

This report summarises the work of the Mental Health Legislation Assurance Committee (MHLAC) at its meeting held on 1st September 2020, with the following highlighted:

- The MHLAC Terms of Reference were reviewed and amendments agreed with the revised Terms of Reference to be presented to the December 2020 meeting for onward approval to the Board.
- An update was received from the Interim Head of Nursing (Mental Health & Learning Disabilities) regarding the newly formed Quality & Safety Assurance / Improvement Group and its future structure and format of meetings.
- An update on the work of the Mental Health Legislation Scrutiny Group was
 provided by the Chair (Head of Service: Adult Mental Health). The Group has
 now reinstated a meeting timetable and will be undertaking further analysis on
 Section 2 and Section 3 service users' experiences and reporting back to MHLAC
 at its December 2020 meeting. The Group will also monitor Out of Area Care and
 contact with service user's carers and families.
- The MHLD Performance Report for Quarter 1, 2020/21 was presented by the Mental Health Legislation Administration Team where data was divided to illustrate Older Adult and Adult service users thereby allowing more scrutiny. The report also provided feedback from service users which indicated that the restriction to telephone only contact from the Tribunals Service was causing some challenges.
- The Director of Mental Health & Learning Disabilities Directorate provided an update on changes made to continue and progress services during the pandemic period, including (but not restricted to) the development of protocols and processes to enable patients to continue to be reviewed (both face to face and via e-platform); increased (7 day) working patterns; conveyance scheme; development of centralised S136 in Bryngofal with 'soft' S136 option in Gorwellion (providing a template for similar options across the counties); medical staffing issues and concerns regarding future estate provisions across the Directorate to enable appropriate social/physical distancing.
- An updated workplan to be developed with the Director of Operations and Director of Mental Health & Learning Disabilities for submission to MHLAC at its December 2020 meeting.
- The amended MHLAC Annual Report (originally received in June by the Board)
 was received and the additional paragraph, on page 5, from the carer
 representative (acknowledging an improvement in the understanding of the
 requirement but that achievement of the intent of the Measure was still work in
 progress) was acknowledged.

Y Penderfyniadau a'r Materion a Ystyriodd y Pwyllgor / Key Decisions and Matters Considered by the Forum:

The Forum received a presentation / update regarding the operational framework for Quarter 2 and the remainder of 2020, followed by a Question & Answer session. The membership was advised that the framework considers how to balance restarting selected services, at the same time as managing the risks associated with COVID-19.

Rhian Bond, Assistant Director of Primary Care, updated the Forum on current practices within General Medical Services (GMS), Community Pharmacy, Dentistry and Optometry. Feedback from Primary Care members was offered.

Elaine Lorton, County Director, Pembrokeshire, provided an update on community care and explained that, increasingly, a regional approach has been taken to provide a consistent response and pathways for proactive, interim, long term and palliative care.

Keith Jones, Director of Secondary Care, provided an update on acute services. Members noted that certain non COVID-19 streams had seen reduced volumes of patients, as an unexpected side-effect of the outbreak; with the greatest concern regarding the impact on cancer services provision. It was also highlighted to the Forum that it is unlikely there will be any significant return of non-urgent surgery throughout Quarter 2, 2020/21.

Following questions regarding non-cancer patients being adversely affected by the existing urgent pathways, it was noted that clinical urgency is the deciding factor in how patients are treated.

The Forum welcomed the updates provided by the presenters, and requested a further update at a later date.
