ADRODDIAD SCAA SBAR REPORT

Sefyllfa / Situation

The purpose of this report is to:

- Update the Board on relevant matters undertaken as Chief Executive of Hywel Dda University Health Board (the UHB) since the previous Board meeting held on 24th September 2020; and
- Provide an overview of the current key issues, both at a local and national level, within NHS Wales.

Cefndir / Background

This report provides the opportunity to present items to the Board to demonstrate areas of work that are being progressed and achievements that are being made, which may not be subject to prior consideration by a Committee of the Board, or may not be directly reported to the Board through Board reports.

Asesiad / Assessment

(1) Register of Sealings

The UHB's Common Seal has been applied to legal documents and a record of the sealing of these documents has been entered into the Register kept for this purpose. The entries at **Appendix A** have been signed by the Chair and Chief Executive or the Deputy Chief Executive (in the absence of the Chief Executive) on behalf of the Board (Section 8 of the UHB's Standing Orders refers).

(2) Consultations

The UHB receives consultation documents from a number of external organisations. It is important that the UHB considers the impact of the proposals contained within these consultations against its own strategic plans, and ensures that an appropriate corporate response is provided to highlight any issues, which could potentially impact upon the

organisation. A status report for Consultation Documents received and responded to is detailed at **Appendix B**, should any Board Member wish to contribute.

(3)Strategic and Operational Issues

Escalation and Intervention Arrangements

In September 2016, as part of the Welsh Government's (WG) Escalation and Intervention Arrangements, the now Minister for Health and Social Services (the Minister) moved the UHB from Enhanced Monitoring to Targeted Intervention. This report provides an update on the recent change of status.

The last Targeted Intervention (TI) meeting was held on 23rd July 2020, and an update report provided to Members in my Chief Executive's Report to Board on 24th September 2020. The next TI meeting was due to be held on 30th September 2020, but was cancelled by WG.

On 5th October 2020, the UHB received a letter from the Director General Health and Social Services/NHS Wales Chief Executive, advising that following the recent tripartite meeting (WG, Audit Wales and Healthcare Inspectorate Wales), WG would be recommending to the Minister that the UHB's escalation status was reduced from Targeted Intervention to Enhanced Monitoring. This was approved by the Minister.

This reduced escalation status was due to the UHB's continued good performance prior to COVID, and the group was complimentary on the UHB's response to the KPMG review. In order for the UHB to move into the lower escalation status of Routine Monitoring, the UHB must focus on future financial plans, dependent on delivering the clinical strategy.

The group raised some concerns and issues for consideration:

- Challenges still remain around the UHB's financial position and management;
- The need to ensure that appropriate planning capacity and leadership is in place recognising the significant commitments in the clinical strategy.

It is proposed to provide the Audit Risk & Assurance Committee (ARAC) with a six monthly assurance report on the progress with these areas. ARAC members received this update at the last meeting held on 20 October 2020.

In the meantime, WG will continue to provide the necessary specialised support and advice to address these issues raised, and will continue to hold Joint Executive Team (JET) and Quality and Delivery (Q&D) meetings when considered necessary.

I would like to take this opportunity to thank our staff who have worked so diligently to allow this positive development to happen, particularly during the COVID pandemic.

Maior Incident Plan

The Major Incident Plan is reviewed on an annual basis and presented to Board for ratification following a review and consultation process.

In light of the current response to Covid-19, the Board is asked to extend approval of the current plan with a view to receiving an updated version in Spring 2021 that will include lessons identified as part of the ongoing pandemic response. An addendum to the current Major Incident Plan is currently being developed to detail the Covid-19 arrangements that would impact on a major incident response. This will be a "live" operational addendum, containing specific site arrangements, which can be amended to reflect site and process changes as they occur.

Retirement of the Director of Planning, Performance & Commissioning

In October 2020, Karen Miles, the Executive Director of Planning, Performance & Commissioning announced that she would be retiring from service. Karen has been employed by the Health Board since its inception in September 2009, initially as Director of Finance, then moving into her current role in 2017.

I would like to thank Karen for all her years of dedication and for her recent work to support our local response to the COVID-19 pandemic. She led her teams to roll out digital solutions at remarkable pace, supporting our clinicians to offer services remotely and staff to work from home where needed, as well as supporting other areas of the UHB's work at a very challenging time. I would like to wish her well in the future and thank her for her support over many years.

Huw Thomas, Director of Finance, will continue to hold Executive responsibility for the portfolio in the interim whilst arrangements are made to realign executive portfolios and appoint to a new Director of Strategic Development and Operational Planning role. The Planning team is also being strengthened, with new posts for capital planning and strategic estates to ensure the Programme Business Case can be taken forward.
